**AUTHORIZATION FOR ACCEPTANCE AND RECEIPT OF STATE GENERAL FUNDS,
APPROVAL OF REQUEST FOR APPROPRIATION ADJUSTMENT
AND
APPROVAL TO AMEND 32 EXISTING DEPARTMENT OF MENTAL HEALTH
LEGAL ENTITY AGREEMENTS
FOR FISCAL YEAR 2006-07
(ALL SUPERVISORIAL DISTRICTS)
(4 VOTES)**

IT IS RECOMMENDED THAT YOUR BOARD:

1. Authorize the acceptance and receipt of State General Fund (SGF) totaling \$16,086,217, from the California Department of Mental Health (CDMH) for Fiscal Year (FY) 2006-07 for mental health services to eligible students identified with disabilities and with an individualized education plan (IEP). Effective upon Board approval, these new SGF funds, which were allocated to the Department of Mental Health (DMH) in accordance with the Budget Act of 2006 – Assembly Bill (AB) 1801 (Chapter 47, Statutes of 2006), will be transferred to the County of Los Angeles on behalf of DMH.
2. Approve and instruct the Director of Mental Health or his designee to prepare, sign, and execute amendments, substantially similar in format to Attachment I, to 32 existing DMH Legal Entity (LE) Agreements as listed on Attachment II to increase the Maximum Contract Amounts (MCA) by \$7,244,806 for FY 2006-07.
3. Delegate authority to the Director of Mental Health or his designee to prepare, sign, and execute further amendments to these LE Agreements and establish as a new MCA the aggregate of each original Agreement and all amendments

"To Enrich Lives Through Effective And Caring Service"

through and including these amendments, provided that: 1) the County's total payments to each contractor under the Agreement for each fiscal year shall not exceed a change of 20 percent from the applicable revised MCA; 2) any such increase shall be used to provide additional services or to reflect program and/or policy changes; 3) the Board of Supervisors has appropriated sufficient funds for all changes; 4) approval of County Counsel and the Chief Administrative Officer (CAO) or their designee is obtained prior to any such Amendment; 5) the parties may, by written Amendment, mutually agree to reduce programs or services without reference to the 20 percent limitation; and 6) the Director of Mental Health shall notify the Board of Supervisors of Agreement changes in writing within 30 days after execution of each Amendment.

4. Approve the Request for Appropriation Adjustment for \$16,086,000 for FY 2006-07 (Attachment III), which will be fully funded by SGF, to increase the DMH spending authority for the purpose of continuing to provide State-mandated mental health services to eligible students identified with disabilities with an IEP.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

Board approval is required to receive the SGF from the CDMH, to allow the County to provide State-mandated mental health services (referred to as "AB 3632" or "Chapter 26.5 services"), without interruption, to eligible students identified with disability and with an IEP, pursuant to Government Code Section 7570 et seq. (Chapter 1747, Statutes of 1984).

Board approval of amendments to 32 LE Agreements will enable Contractors identified in Attachment II to be significantly reimbursed for continuing to deliver federally mandated AB 3632 mental health services.

The Department of Children and Family Services (DCFS) will also receive a portion of this allocation totaling \$7,990,024, for reimbursement of residential placement costs. DMH is also allocating \$41,768 for out-of-state placement expenditures projected for FY 2006-07 as well as \$809,619 for administrative overhead.

Implementation of Strategic Plan Goals

The recommended Board actions are consistent with the Principals of the Countywide Strategic Plan Programmatic Goal No. 5, "Children and Families' Well Being," and Goal No. 7, "Health and Mental Health." These funds will assist in maintaining the level of special education services for eligible students with disabilities with an IEP.

FISCAL IMPACT/FINANCING

There is no increase in net County cost.

The Request for Appropriation Adjustment will be fully funded by SGF revenue of \$16,086,000 for FY 2006-07. The Appropriation Adjustment will provide spending authority for the purpose of continuing to provide State-mandated mental health services to eligible students identified with disabilities with an IEP.

FACTS AND PROVISIONS/LEGAL REQUIREMENTS

In 1984, the California Legislature enacted AB 3632 in order to maximize and coordinate the provision of mental health services to seriously emotionally disturbed (SED) children by State and local government agencies. Since the inception of AB 3632, DMH has delivered mental health services to clients through a network of directly-operated and community-based provider agencies. However, counties have voiced concerns that this mandated program has not been fully funded. With the passage of Proposition 1A, the State has made available a new categorical funding source of \$52 million statewide which will augment funding for AB 3632 mental health services to special education pupils.

The methodology the CDMH utilized for allocating these new categorical funds was based upon each County's proportionate share of the state mandated claims in FY 2004-05. Accordingly, the County's claim, which also included residential care claims from DCFS totaled \$19,580,271. This represented 30.94 percent of the State mandated claims, resulting in an award amount of \$16,086,217. DCFS will receive \$7,990,024 of this amount as reimbursement for residential care costs. DMH is also allocating \$41,768 for out-of-state placement expenditures projected for FY 2006-07 as well as \$809,619 for administrative overhead.

The amendments will enable Contractors identified in Attachment II to be significantly reimbursed for continuing to deliver federally mandated AB 3632 mental health services. Funding in prior fiscal years has not been adequate to meet the mandated need. Fortunately with the passage of Proposition 1A, the California Legislature must either suspend a mandate on counties, or fully pay the mandate. This new categorical funding source from the State will go a long way in closing the funding gap in this program and ensure reimbursement to counties for providing AB 3632 mandated mental health services.

The attached Amendment format has been approved as to form by County Counsel. The CAO has reviewed the proposed actions. Clinical and administrative staff of DMH will also continue to administer and supervise the agreements, evaluate programs to ensure that quality services are being provided to clients, and ensure that Agreement provisions and Departmental policies are being followed.

CONTRACTING PROCESS

All contract providers who currently serve clients eligible under Chapter 26.5 California Government Code AB 3632 are allocated additional funding based on a number of factors. These factors took into consideration actual expenditures by contractors in FY 2005-06, geographic correlation to Service Areas with high rates of identification and referral of eligible clients and low rates of Medi-Cal eligibility and the desire to improve access to underserved populations within the eligible pool of clients. Since the school districts retain the exclusive responsibility for the identification and referral of students for the Chapter 26.5 program, the allocation of resources is not uniform throughout the eight Service Areas.

IMPACT ON CURRENT SERVICES

Board approval of the Acceptance of the SGF totaling \$16,086,217 from the CDMH and Amendments to 32 LE Agreements will enable the County of Los Angeles to continue to provide mandated mental health treatment services and residential placement to eligible disabled students in accordance with federal and State statute and regulations.

AMENDMENT NO. _____

THIS AMENDMENT is made and entered into this ___ day of _____, 2007, by and between the COUNTY OF LOS ANGELES (hereafter "County") and _____ (hereafter "Contractor").

WHEREAS, County and Contractor have entered into a written Agreement, dated _____, identified as County Agreement No. _____, and any subsequent amendments (hereafter collectively "Agreement") **if applicable**; and

WHEREAS, for Fiscal Year 2006-07 County and Contractor intend to amend Agreement only as described hereunder; and

WHEREAS, for Fiscal Year 2006-07, County and Contractor intend to **add** State General Funds (SGF) in the amount of \$ _____ to the Maximum Contract Amount (MCA) for the provision of AB 3632 mental health services to meet the needs of seriously emotionally disturbed (SED) children; and

WHEREAS, for Fiscal Year 2006-07, the revised MCA will be \$ _____

NOW, THEREFORE, County and Contractor agree that Agreement shall be amended only as follows:

1. Paragraph 4 (FINANCIAL PROVISIONS), Subparagraphs C (Reimbursement For Initial Period) and D (Reimbursement If Agreement Is Automatically Renewed) shall be deleted in its/their entirety and the following substituted therefore (edit as necessary):

C. Reimbursement For Initial Period: The Maximum Contract Amount for the Initial Period of this Agreement as described in Paragraph 1 (TERM) shall not exceed _____ DOLLARS (\$) and shall consist of County, State, and/or Federal funds as shown on the Financial Summary. This Maximum Contract Amount includes Cash Flow Advance which is repayable through cash and/or appropriate Service Function Code (SFC) units and/or actual and allowable costs as authorized by other provisions of this Agreement. Notwithstanding any other provision of this Agreement, in no event shall County pay Contractor more than this Maximum Contract Amount for Contractor's performance hereunder during the Initial Period. Furthermore, Contractor shall inform County when up to 75 percent (75%) of the Maximum Contract Amount has been incurred. Contractor shall send such notice to those persons and addresses which are set forth in Paragraph 61 (NOTICES).

2. Financial Summary - ___ for Fiscal Year 2006-07 shall be deleted in its entirety and replaced with Financial Summary - ___ for Fiscal Year 2006-07, attached hereto and incorporated herein by reference. All references in Agreement to Financial Summary - ___ for Fiscal Year 2006-07 shall be deemed amended to state "Financial Summary - ___ for Fiscal Year 2006-07."
3. Contractor shall provide services in accordance with the Contractor's Fiscal Year _____ Negotiation Package for this Agreement and any addenda thereto approved in writing by Director.
4. Except as provided in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
