**APPROVAL TO SUPERSEDE
110 LEGAL ENTITY AGREEMENTS
FOR FISCAL YEARS 2008-09 AND 2009-10
(ALL SUPERVISORIAL DISTRICTS)
(3 VOTES)**

SUBJECT

Request approval to supersede 110 Legal Entity agreements to incorporate revised and new standard contract provisions effective January 1, 2009, and update the Maximum Contract Amounts as approved under delegated authority.

REQUEST

Approve and instruct the Director of Mental Health, or his designee, to prepare, sign, and execute 110 Legal Entity (LE) agreements, as listed in Attachment I, that supersede the prior LE agreements, and any future agreements that should be superseded, to enable Department of Mental Health (DMH) to ensure the uniform implementation of revised and new provisions required in all DMH LE agreements which provide for mental health services to severely and persistently mentally ill adults, seriously emotionally disturbed (SED) children, adolescents, and their families. The three revised or mandated provisions are Performance Standards and Outcome Measures, Local Small Business Enterprise Preference Program and the updated Safely Surrendered Baby Law Fact Sheet.

Delegate authority to the Director of Mental Health, or his designee, to prepare, sign, and execute future amendments to these LE agreements, provided that: 1) the County's total payments to a contractor under each agreement will not exceed a 20 percent increase from the applicable Board-approved annual Maximum Contract Amount (MCA) and the Institution for Mental Diseases (IMD) per diem rate increase does not exceed the rates per the State directive; 2) any such increase is used to provide additional services or to reflect program or policy changes; 3) your Board has appropriated sufficient funds for all changes; 4) approval by County Counsel and the Chief Executive Officer (CEO), or their designee, is obtained prior to any such Amendment; 5) County and contractor may, by written amendments, reduce programs or services and revise the applicable MCA, provided that any amendments which reduce programs or services will be consistent with the principles agreed to in DMH's stakeholder process; and 6) the Director of Mental Health notifies the Board of Supervisors of agreement changes in writing within 90 days after execution of each Amendment.

Approve and authorize to supersede revisions to the last Board approved MCA for these 110 LE agreements, some of which may have increased or decreased under delegated authority since their last Board approved MCA.

PURPOSE/JUSTIFICATION OF RECOMMENDED ACTIONS

The new LE agreements will ensure compliance with all revised and new provisions, and that LE contractors comply with all applicable Federal, State, and County policies and procedures. There has been an ongoing review of all DMH agreements with contractors, and the CEO and Auditor-Controller have previously recommended that there be uniformity of terms and conditions. Some of these LE agreements may have received increases or decreases in funding under delegated authority since their last Board approved MCA.

The FY 2008-09 annual MCA for each LE agreement is shown in Attachment I. The total funding for all 110 agreements is \$601,440,889 which will be funded by the following revenue sources that are included in DMH's FY 2008-09 Final Budget:

1) State Revenues	\$240,576,356
2) Federal Revenues	246,590,764
3) Intrafund Transfers	24,057,636
4) NCC/Sales Tax Realignment	<u>90,216,133</u>

For FY 2009-10, funding will be requested during DMH's annual budget process. The annual MCAs for each agreement for FY 2009-10, shown in Attachment I, may be subject to change because of budgetary factors which may impact the funding that is given to the County by the State or the Federal government on an annual basis. There is no increase in net County cost.

BACKGROUND

Attachment I lists the 110 LE contractors that are going to be superseded, types of services provided, FY 2008-09 maximum initial annual MCA, and affected Supervisorial districts. Superseding these agreements will ensure that contractors are in compliance with all revised and new provisions required in County contracts. Superseding these agreements will not change the existing contract term.

These LE agreements with mental health services contractors provide a broad range of mental health services to severely and persistently mentally ill adults, SED children,

adolescents, and their families, pursuant to the California Welfare and Institutions Code (WIC), Division 5, Part 2, Chapter 1, Section 5602. These mental health services include, but are not limited to, diagnosis, evaluation, treatment, day care, respite care, living arrangements, community skill training, information, referrals, consultation, and community services.

The agreement format includes three revised or new mandated provisions: Performance Standards and Outcome Measures, Local Small Business Enterprise Preference Program and the updated Safely Surrendered Baby Law Fact Sheet. The CEO has reviewed the proposed actions.

Clinical and administrative staff of DMH will continue to administer and monitor contractors' adherence to the agreements, evaluate programs to ensure that quality services are being provided to clients, and ensure that agreement provisions and Departmental policies are being followed. As mandated by your Board, the performance of all contractors is evaluated by DMH on an annual basis to ensure the contractors' compliance with all contract terms and performance standards.
