AUTHORIZATION TO SUPERSEDE NINETY-THREE (93) PHARMACY AGREEMENTS FOR FISCAL YEARS 2007-08, 2008-09, AND 2009-10 (ALL SUPERVISORIAL DISTRICTS) (3 VOTES)

REQUEST

Approve and authorize the Director of Mental Health or his designee to prepare, sign, and execute the supersession of ninety-three (93) Pharmacy Agreements, as listed in the Attachment for Fiscal Years (FY) 2007-08, 2008-09 and 2009-10. These pharmacies provide medication support to our clients who reside in the County at a total cost of \$33,868,000, funded by Sales Tax Realignment Funds.

Authorize the Director or his designee to enter into new agreements with additional Pharmacies, and authorize the Director or his designee to prepare, sign, and execute amendments to these Agreements, provided that: 1) the County's total payments to each contractor under the Agreement for each fiscal year shall not exceed an increase of 20% from the applicable revised contracted rate; 2) any increase shall be used to provide additional services or to reflect program and/or policy changes; 3) the Board of Supervisors has appropriated sufficient funds for all changes; 4) approval of County Counsel and the Chief Administrative Officer (CAO) or their designee is obtained prior to any such Amendment; 5) County and contractor may by written amendments reduce programs or services and revise the applicable contracted rate; and 6) the Director of Mental Health shall notify the Board of Supervisors of Agreement changes in writing within 30 days after execution of each Amendment.

PURPOSE/JUSTIFICATION

Board approval is requested to ensure that all pharmacy agreements are in compliance with revised contract provisions. There has been an ongoing review of all agreements with contractors. The CAO, County Counsel, and Auditor-Controller have previously recommended that there be uniformity of all terms and conditions.

BACKGROUND

The supersession of 93 Pharmacy Agreements, as listed in the Attachment, will continue to provide lower cost medications at neighborhood pharmacies to eligible recipients of health care in Los Angeles County. Physicians in contracted and directly operated mental health programs write prescriptions which are filled by local private pharmacies. This program serves as a critical component in the delivery of mental

health services, as prescribed medications play a vital role in the treatment of mental health clients.
