**AUTHORIZATION TO RENEW 139 SPECIALIZED AGREEMENTS  
(ALL SUPERVISORIAL DISTRICTS)**

**REQUEST**

Request Board authorization for the Department of Mental Health's (DMH) renewal of the following 139 specialized agreements:

- 1) Fifty-six (56) Pharmacy Agreements, as listed in Attachment A.
- 2) Eleven (11) Community Care Residential Facility (CCRF) Agreements, as listed in Attachment B.
- 3) Two (2) Out-of-State Child Placement Mental Health Services Agreements, as listed in Attachment C.
- 4) One (1) Services Agreement with Lifesigns, Inc., as listed in Attachment D.
- 5) Two (2) State Hospital Escort Services Agreements, as listed in Attachment E.
- 6) Three (3) agreements between the County of Los Angeles - Department of Mental Health and school districts, as listed in Attachment F.
- 7) One (1) Affiliation Agreement for Forensic Fellows Services with the University of Southern California (USC), as listed in Attachment G.
- 8) Sixty-two (62) Services Agreements for the Clinical Assessment Programs, as listed in Attachment H.
- 9) One (1) Revenue Subcontract Agreement for the Supportive Housing Program for the Santa Monica Dually Diagnosed Project between the County of Los Angeles DMH on behalf of Edmund D. Edelman Westside Mental Health Center and Venice Family Clinic, as listed in Attachment I.

**PURPOSE /JUSTIFICATION**

Board approval is required due to the June 30, 2005, expiration date of these 139 agreements, and new contracts are required to continue the provision of mental health services without interruption.

## **CONTRACTORS**

- 1) Fifty-six (56) pharmacies located in Los Angeles County will fill clients' medications prescribed by mental health physicians.
- 2) Eleven (11) CCRFs will provide basic board and care services, which include personal care, supervision, assistance, guidance, and training of clients in a 24-hour residential setting. As part of the clients' total care, arrangements are made for clients to receive personal and incidental (P and I) expenses and mental health services, which may be rendered off-site at facilities other than the contractors.
- 3) Two (2) out-of state child placement mental health services providers will provide a comprehensive residential treatment program to seriously emotionally disturbed (SED) children and adolescents who are residents of the County of Los Angeles but who have been placed out-of-state because they have either failed in multiple local residential treatment programs or have been refused admission by a multitude of mental health programs in California.
- 4) Lifesigns, Inc. will provide sign language interpreters on an as needed basis for clinical communication between hearing-impaired clients and DMH staff.
- 5) Two (2) State Hospital escort services providers will provide transportation and escort services to mentally ill patients who are Lanterman-Petris Short conservatees of Los Angeles County. These patients are transported to and from various courts in the greater Los Angeles area for legal proceedings.
- 6) Three (3) school districts--ABC Unified School District, Los Angeles Unified School District (LAUSD), and Montebello Unified School District--will allow DMH clinical staff to provide mental health services at school sites.
- 7) USC will provide Institute of Psychiatry, Law, and Behavioral Science fellows, to provide services that include, but are not limited to: individual psychotherapy in the Forensic Outpatient Unit, group psychotherapy, court-ordered evaluations, psychotropic medication monitoring, psychological evaluation, consultation, and participation in ongoing research.
- 8) Sixty-two (62) licensed clinicians will provide clinical assessments to SED children and adolescents who are referred by local school districts or educational agencies.

- 9) Venice Family Clinic will continue to fulfill its obligations under the term of the grant awarded by the United States Department of Housing and Urban Development (HUD) for mental health services provided to homeless dually diagnosed adults through a Revenue Subcontract Agreement for the Supportive Housing Program for the Santa Monica Dually Diagnosed Project with the County of Los Angeles DMH on behalf of the Edmund D. Edelman Westside Mental Health Center.

### **FISCAL SUMMARY**

The specific financing of these 139 agreements is as follows:

- 1) **Pharmacy Agreements:** The renewal of 56 Pharmacy Agreements will be funded with Sales Tax Realignment funds in the amount of \$30,120,000, which are included in DMH's FY 2005-2006 Proposed Budget. The County reimburses each contractor at the rate of 0.85 of the Average Wholesale Price (AWP), which is the industry standard, plus a professional fee of \$3.35 for each prescription dispensed pursuant to the Agreement for medications supplied from the pharmacy's own stock. Funding for FYs 2006-2007, 2007-2008, 2008-2009, and 2009-2010 will be requested through DMH's annual budget process. There is no MCA for these 56 agreements.
- 2) **CCRF Agreements:** The renewal of 11 CCRF Agreements will be funded with Sales Tax Realignment funds in the amount of \$2,297,000, which are included in DMH's FY 2005-2006 Proposed Budget. DMH funds the Interim Funding (IF) Program from an allocation pool, which reimburses facility operators at the board and care rate established by California State Department of Social Services (SDSS) for a client's room and board and P and I expenses prior to the establishment of Supplemental Security Income (SSI) eligibility. Once a client's SSI application has been approved, retroactive SSI payments are used to reimburse this fund. Funding for FYs 2006-2007 and 2007-2008 will be requested through DMH's annual budget process. There is no MCA for these 11 agreements.
- 3) **Out-Of-State Child Placement Mental Health Services Agreements:** The renewal of two (2) Out-of-State Child Placement Mental Health Services Agreements will be funded at the rates detailed in Attachment C. These rates are based on providers' costs, prevailing wages, cost-of-living, and negotiated rates with other counties, public and private agencies, and insurance companies. These agreements will be funded with Individuals with Disabilities

Education Act (IDEA) funds in the amount of \$4,841,000, which are included in DMH's FY 2005-2006 Proposed Budget. Funding for FYs 2006-2007 and 2007-2008 will be requested through DMH's annual budget process. There is no MCA for these two (2) agreements.

- 4) Services Agreement: The renewal of one (1) Services Agreement with Lifesigns, Inc. will be funded with \$50,000 of Sales Tax Realignment funds, which are included in DMH's FY 2005-2006 Proposed Budget. Funding for FYs 2006-2007 and 2007-2008 will be requested through DMH's annual budget process. Sign language services are paid in accordance with a Payment Schedule at an hourly negotiated rate with a minimum of two (2) hours for scheduled services and at another negotiated rate for emergency services. There is no MCA for this Agreement.
- 5) State Hospital Escort Services Agreements: The renewal of two (2) State Hospital Escort Services Agreements will be funded with \$276,694 of Sales Tax Realignment funds, which are included in DMH's FY 2005-2006 Proposed Budget. Funding for FY 2006-2007 will be requested through DMH's annual budget process. There is no MCA for these two (2) agreements.
- 6) Agreements between the County of Los Angeles - Department of Mental Health and specified school districts: The renewal of three (3) agreements between the County of Los Angeles - Department of Mental Health and school districts--ABC Unified School District, LAUSD, and Montebello Unified School District--for FYs 2005-2006, 2006-2007, 2007-2008, 2008-2009, and 2009-2010 for the provision of on-site mental health services by DMH staff does not involve monetary funds, and, thus, there is no MCA for these three (3) agreements.
- 7) Affiliation Agreement for Forensic Fellows Services: The renewal of one (1) Affiliation Agreement for Forensic Fellows Services with USC will be funded with \$226,200 of Sales Tax Realignment funds, which are included in DMH's FY 2005-2006 Proposed Budget. Funding for FYs 2006-2007, 2007-2008, 2008-2009, and 2009-2010 will be requested through DMH's annual budget process. USC is paid in accordance with the Fee Schedule established for each fiscal year of the term of the Agreement. There is no MCA for this Agreement.
- 8) Services Agreements for the Clinical Assessment Programs: The renewal of 62 Services Agreements for the Clinical Assessment Programs will be funded

with \$200,000 in Federal Financial Participation (FFP) Medi-Cal, \$163,480 in Early and Periodic Screening, Diagnostic, and Treatment – State General Fund (EPSDT-SGF), and \$36,520 in Sales Tax Realignment revenues, for a total of \$400,000 for the Assembly Bill (AB) 3632 Clinical Assessment Program, and \$100,000 annually through Department of Children and Family Services (DCFS), \$269,117 in FFP Medi-Cal, and \$219,883 in EPSDT-SGF revenues, for a total of \$589,000 for the Specialized Foster Care (D-Rate) Clinical Assessment Program, which are included in DMH's FY 2005-2006 Proposed Budget. Funding for FYs 2006-2007 and 2007-2008 will be requested through DMH's annual budget process. Assessors are paid an established hourly rate by professional licensure in accordance with the Agreement's Payment Schedule.

- 9) Revenue Subcontract Agreement for the Supportive Housing Program for the Santa Monica Dually Diagnosed Project: The renewal of the Revenue Subcontract Agreement between the County of Los Angeles DMH on behalf of Edmund D. Edelman Westside Mental Health Center and Venice Family Clinic will allow DMH to continue to receive revenue in the amount of \$102,000 for FY 2005-2006 for the provision of mental health services to homeless dually diagnosed adults.

All of these agreements permit the County to reduce the contracted daily rates and MCAs or terminate the agreements, whichever is applicable under the terms of the agreements, if, as a result of the adoption of the County and State Budgets, funding for these agreements is reduced.

### **CONTRACTING PROCESS**

All of the 139 contractors have existing agreements with DMH, which will expire on June 30, 2005, and are being renewed because of the continuing need for their specialized services throughout Los Angeles County. As mandated by the Board, the performance of all contractors is evaluated by DMH on an annual basis to ensure the contractors' compliance with all contract terms and performance standards.
