SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 174 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, and Medi-Cal Professional Services Agreements processed in the month of April 2009, as follows:

- 1. Amendment No. 1 (MH040064) with Mid-Valley Recovery Services, Inc.,** adds Mental Health Services Act (MHSA) funding in the amount of \$105,600 to expand services pertaining to the Empowerment and Advocacy Division. The Total Contract Amount (TCA) for Fiscal Year (FY) 2008-09 will be increased in the amount of \$105,600.
- 2. Amendment No. 10 (MH120194) with Barbour and Floyd Medical Associates** decreases MHSA Adult Field Clinical Capable Services (FCCS) Local Mental Health Plan (MHP) non-Medi-Cal funds by \$25,122, decreases non-Early and Periodic Screening, Diagnosis and Treatment (EPSDT) by \$100,012, increases MHSA Older Adult FCCS Local MHP non-Medi-Cal by \$25,122, and increases non-EPSDT by \$100,012. There is no change to the Maximum Contract Amount (MCA).
- 3. Amendment No. 12 (MH120248) with Penny Lane Centers** adds Department of Children and Family Services (DCFS) Intensive In-Home Enhanced Specialized Foster Care Katie A. by \$9,080, increases EPSDT-Federal Financial Participation (FFP) by \$66,666, and increases EPSDT-State General Funds (SGF) by \$57,587, with a revised MCA of \$14,194,733.
- 4. Amendment No. 11 (MH120260) with St. Joseph Center** increases County General Funds (CGF) by \$60,000 for FY 2008-09; adds a new service delivery site (St. Joseph Center Homeless Service Center) located at 404 Lincoln Blvd., Venice, CA 90291, Provider Number (PN) To Be Determined (TBD); and adds Mode 60 (Support Services) and Service Function Code (SFC) 64 (Client

Supportive Services [CSS]); Mode 15 (Outpatient Services) SFCs 01-09 (Targeted Case Management) [TCM] 10-19/30-59, (Mental Health Services) [MHS] 60-69 (Medication Support) and 70-79 (Crisis Intervention); Mode 45 (Outreach Services) 10-19 (Mental Health Promotion) and 20-29 (Community Client Services) [CCS]; and adds Service Exhibit Supportive Services—Residential Programs to the new delivery site, with a revised MCA of \$853,264.

5. **Amendment No. 10 (MH120267) with Telecare Corporation** reimburses services for PN 7277 at the lower of actual costs as reported in contractor's cost report under this agreement, and if audited as finalized following any final appeal decision, or \$413 per diem for the Modes 05, 20-29 SFC range and \$24.78 per diem for Modes 60, 40-49 SFC range. There is no change to the MCA.
6. **Amendment No. 11 (MH120267) with Telecare Corporation** revises the Provisional Cost Reimbursement (CR) Rate for the following Short-Doyle/Medi-Cal (SD/MC) services for the period of July 1, 2008 through June 30, 2009: Mode 15, SFCs 01-09, TCM from \$1.79 to \$1.86; Mode 15, SFCs 10-19/30-59, MHS from \$2.26 to \$2.40; Mode 15, SFCs 60-69, Medication Support from \$4.39 to \$4.44; Mode 15, SFCs 70-79, Crisis Intervention from \$3.79 to \$3.57. There is no change to the MCA.
7. **Amendment No. 1 (MH120334) with Community Family Guidance Center** increases the Provisional CR Rate for Outpatient Services: TCM, Mode 15, SFCs 01-09 from \$1.53 to \$1.70; MHS, Mode 15, SFCs 10-19/30-59 from \$2.00 to \$2.19; Therapeutic Behavioral Services (TBS), Mode 15, SFC 58 from \$2.00 to \$2.19; Medication Support, Mode 15, SFCs 60-69 from \$2.12 to \$3.60; and Crisis Intervention, Mode 15, SFCs 70-79 from \$1.99 to \$2.96. There is no change to the MCA.
8. **Amendment No. 2 (MH120365) with Intercommunity Child Guidance Center** increases MHSA EPSDT Children Local by \$7,491, increases EPSDT-FFP Full Service Partnership (FSP) Children by \$55,000, increases EPSDT-SGF FSP Children by \$47,509, and increases MHSA local MHP non-Medi-Cal FSP Children by \$10,000, with a revised MCA of \$5,078,600.
9. **Amendment No. 3 (MH120375) with Mental Health America of Los Angeles (MHALA)** reduces MHSA Wellness Center (non-Client Run) by \$215,000, CGF by \$102,000, FFP by \$72,000, and CGF FFP by \$72,000, with a revised MCA of \$14,396,629.

- 10. Amendment No. 2 (MH120381) with Pacific Clinics** reallocates the Assertive Community Treatment (ACT) funds of MHS by shifting MHS Adult FSP CSS by \$1,130,463 to MHS Adult FSP MHS by \$614,093, MHS Adult Field Capable Clinical Services (FCCS) MHS by \$496,370, and MHS Adult FCCS CSS (Flex Funds) by \$20,000; shifts ACT FFP by \$1,364,650 to MHS Adult FSP MHS FFP by \$555,608 and MHS Adult FCCS MHS FFP by \$809,042; shifts ACT CGF Medi-Cal by \$1,364,650 to Local MHP non-Medi-Cal CGF; shifts MHS Wellness Centers by \$200,000 to MHS Adult FCCS MHS; shifts MHS Wellness Centers-Client Run by \$200,000 to MHS Adult FCCS MHS; shifts MHS TAY FSP-CSS by \$400,000 to MHS TAY FSP MHS; shifts MHS Older Adult FSP CSS (Flex Funds) by \$110,000 to MHS Older Adult FSP MHS; shifts MHS Family Supportive Services by \$300,000 to MHS TAY FSP MHS; reduces MHS Child FSP EPSDT by \$8,172, EPSDT-SGF by \$51,828 and EPSDT-FFP by \$60,000; adds MHS Child FSP HF match funds by \$42,000 and HF FFP by \$78,000; reduces MHS TAY FSP MHS by \$362,075 and adds MHS TAY FSP MHS non-EPSDT Medi-Cal by \$100,000, MHS TAY FSP MHS-EPSDT Medi-Cal by \$11,037, non-EPSDT FFP by \$100,000, EPSDT FFP by \$81,037 and EPSDT-SGF by \$70,000; reduces MHS Adult FSP MHS by \$100,000 and adds MHS Adult FSP-non-EPSDT Medi-Cal by \$50,000 and adds non-EPSDT Medi-Cal FFP by \$50,000; reduces MHS Adult FCCS MHS by \$1,200,000 and adds MHS Adult FCCS non-EPSDT Medi-Cal by \$600,000 and non-EPSDT FFP Medi-Cal by \$600,000; reduces MHS Older Adult FCCS MHS by \$160,000 and adds MHS Older Adult FCCS non-EPSDT Medi-Cal by \$80,000 and non-EPSDT FFP Medi-Cal by \$80,000; and reduces MHS Adult Wellness Centers by \$600,000 and adds MHS Wellness Centers non-EPSDT Medi-Cal by \$300,000 and non-EPSDT FFP Medi-Cal by \$300,000. There is no change to the MCA.
- 11. Amendment No. 1 (MH120389) with Providence Community Services, LLC,** adds Provisional Rate under CR for Outreach Services, Mode 45, SFCs 10-19 at an hourly rate of \$63.01, under PN 7711. There is no change to the MCA.
- 12. Amendment No. 1 (MH120399) with St. John's Hospital and Health Center** changes the following Provisional Rates under CR Mode 10, SFCs 85-89 (Day Treatment Intensive) from \$189.33 to \$202.43; Mode 15, SFCs 01-09 (TCM) from \$1.89 to \$2.02; Mode 15, SFCs 10-19/30-59 (MHS) from \$2.44 to \$2.61; Mode 15, SFCs 60-69 (Medical Support Services) from \$4.51 to \$4.82; and Mode 15, SFCs 70-79 (Crisis Intervention) from \$3.63 to \$3.88. There is no change to the MCA.

13. **Amendment No. 1 (MH120347) with Exodus Recovery, Inc.**, increases MHSA Local Mental Health Plan (MHP) non-Medi-Cal funds by \$225,000, MHSA non-EPSTD match by \$75,000, and non-EPSTD-FFP by \$75,000, with a revised MCA of \$8,295,400.
14. **Amendment No. 2 (MH120351) with Foothill Family Service** adds Outreach Services Mode 45, SFC 10, under PNs 7330, 7331, 7407, and 7463 at the rate of \$50.00 hourly. There is no change to the MCA.
15. **Amendment No. 3 (MH120351) with Foothill Family Service** decreases Healthy Families (HF) CGF match funds by \$30,021, increases MHSA Child FCCS by \$25,518, and increases MHSA TAY FCCS by \$4,503. There is no change to the MCA.
16. **Amendment No. 1 (MH120375) with MHALA** decreases EPSTD-CGF funds by \$33,249, EPSTD-FFP funds by \$244,120, EPSTD-SGF by \$210,871, MHSA FSP Adult MHS Local MHP non-Medi-Cal funds by \$210,871 and increases non-EPSTD-CGF by \$33,249, non-EPSTD MHSA FSP Adult MHS by \$210,871 and non-EPSTD-FFP funds by \$244,120, with a revised MCA of \$14,825,629.
17. **Amendment No. 4 (MH120375) with MHALA** decreases Local MHP non-Medi-Cal-CGF by \$203,750 and non-EPSTD-CGF by \$61,938 and increases MHSA Adult FSP MHS Local MHP non-Medi-Cal funds and non-EPSTD Medi-Cal by \$86,267 and \$28,733, respectively; MHSA Adult FCCS MHS Local non-Medi-Cal funds and non-EPSTD Medi-Cal by \$74,391 and \$33,205, respectively; and MHSA Outreach and Engagement MHS Local MHP non-Medi-Cal funds by \$43,092. There is no change to the MCA.

19. **Amendment No. 7 (MH120375) with MHALA** decreases MHSA FSP Adult CSS by \$81,325, with a revised MCA of \$14,315,304.
20. **Amendment No. 1 (MH120414) with Traveler's Aid Society of Los Angeles California** decreases Local MHP non-Medi-Cal-CGF by \$4,010, and increases MHSA Outreach and Engagement Local MHP non-Medi-Cal by \$4,010. There is no change to the MCA.

21. **Amendment No. 1 (MH120420) with Vista Del Mar Child and Family Services** adds Outreach Services, Mode 45, SFCs 10-19, at the Provisional CR rate of \$60.00, and adds CCS, Mode 45, SFCs 20-29, at the Provisional CR rate of \$60.00, under the existing PNs 7196 and 7714.

There is no change to the MCA.
25. **Amendment No. 5 (MH120381) with Pacific Clinics** changes the service delivery site for Pacific Clinics' Oak Knoll School Program, under existing PN 1974 from 330 S. Oak Knoll Avenue, #210, Pasadena, CA 91101 to 3126 North Glenrose Avenue, Altadena, CA 91001.

***The following four (4) amendments to LE Agreements (26-29) increase, decrease, or shift MHSA Wellness Centers-Non Client Run Funds:***

26. **Amendment No. 1 (MH120343) with Emotional Health Association dba SHARE! The Self-Help and Recovery Exchange** decreases MHSA-Adult-Wellness Center-Client Run by \$400,000. There is no change to the MCA.

27. **Amendment No. 1 (MH120344) with ENKI Health and Research System, Inc.**, increases non-EPSTD-FFP by \$300,000 and shifts \$100,000 from MHSA-Wellness Centers to MHSA-Wellness Centers match and \$200,000 from MHSA Adult FCCS-MHS to MHSA Adult FCCS match, with a revised MCA of \$27,471,200.
28. **Amendment No. 3 (MH120347) with Exodus Recovery, Inc.**, increases MHSA-Adult-Wellness Centers-Non Client Run by \$215,000, CGF by \$102,000, non-EPSTD-FFP by \$72,000 and CGF-FFP by \$72,000; It also adds a new service delivery site located at 11905 S. Central Ave., Los Angeles, CA 90050, under new PN TBD. Services to be provided at this site include Mode 45, SFCs 10-19, Mental Health Promotion and Mode 45, SFCs 20-29, CCS, under MHSA FSP, with a revised MCA of \$8,756,400.
29. **Amendment No. 2 (MH120375) with MHALA** increases MHSA Wellness Centers by \$32,000 for services at PN 7576, located at 1078 Atlantic Boulevard., Long Beach, CA 90813, with a revised MCA of \$14,857,629.

There is no change to the MCA.
- 45. Amendment No. 1 (MH120318) with Amanecer Community Counseling Services, Inc.,** decreases Local MHP non-Medi-Cal CGF by \$29,358 and non-EPSTD–CGF by \$50,154 and increases MHSA Adult FCCS Local non-Medi-Cal by \$29,358 and non-EPSTD Medi-Cal by \$50,154. There is no change to the MCA.

47. **Amendment No. 1 (MH120329) with Child and Family Guidance Center** decreases Local MHP non-Medi-Cal–CGF by \$60,000 and HF CGF by \$25,000 and increases MHSA FCCS Local MHP non-Medi-Cal by \$60,000 HF by \$25,000. There is no change to the MCA.
  48. **Amendment No. 1 (MH120340) with El Centro de Amistad, Inc.,** decreases non-ESPDT–CGF by \$5,750, increases MHSA Adult FCCS Medi-Cal by \$5,750 and non-ESPDT Medi-Cal by \$5,750 and adds new services at PNs 7371 and 7050, Mode 15, SFCs 70-79, Crisis Intervention at \$3.88; Mode 60, SFCs 60-69, Cases Management Support at \$2.02; and Mode 60, SFCs 64, 70-79 CSS. There is no change to the MCA.

There is no change to the MCA.
  50. **Amendment No. 1 (MH120353) with Gateways Hospital and Mental Health Center** decreases Local MHP non-Medi-Cal–CGF by \$15,338 and increases MHSA TAY Probation Camp Co-Occurring Disorders (COD) Local MHP non-Medi-Cal by \$15,338 to be provided at Camps Scott/Scudder & Challenger. There is no change to the MCA.
  51. **Amendment No. 1 (MH120360) with Heritage Clinic and The Community Assistance Program for Seniors** decreases non-ESPDT–CGF by \$54,618 and increases non-ESPDT Medi-Cal by \$54,618. There is no change to the MCA.
  52. **Amendment No. 2 (MH120362) with Hillview Mental Health Center, Inc.,** decreases Local MHP non-Medi-Cal–CGF by \$60,777 and non-ESPDT–CGF by \$200,681 and increases MHSA TAY FSP Local MHP non-Medi-Cal by \$1,000, non-ESPDT Medi-Cal by \$681, MHSA Adult FCCS Local MHP non-Medi-Cal by \$51,027, non-ESPDT Medi-Cal by \$175,000, MHSA Older Adult FCCS Local MHP non-Medi-Cal by \$8,750 and non-ESPDT Medi-Cal by \$25,000. There is no change to the MCA.

54. **Amendment No. 2 (MH120388) with Prototypes** decreases non-ESPDT-CGF by \$30,000 and HF CGF by \$8,750 and increases MHSA Wellness Center(s) non-ESPDT Medi-Cal by \$30,000, MHSA TAY FCCS HF by \$8,750. There is no change to the MCA.
