SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 105 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of seven (7) new Agreements processed in the month of May 2009, as follows:

- Amendment No. 1 (MH050026) with Inez K. Mann dba Mann and Associates** intends to renew this agreement for one (1) year, beginning July 1, 2009 through June 30, 2010. The Total Contract Amount (TCA) shall be increased in the amount of \$25,000. The revised Maximum Contract Amount (MCA) will be \$150,000.
- Amendment No. 8 (MH120231) with Homes for Life Foundation** intends to implement a technical adjustment to change the Negotiated Rate (NR) for Crisis Intervention (Mode 15, Service Function Codes (SFCs) 70-79) from \$3.06 to \$3.15. There is no change to the MCA.
- Amendment No. 1 (MH120336) with David & Margaret Home, Inc.,** increases Cost Reimbursement (CR) Rates for the following Short-Doyle/Medi-Cal (SD/MC) services: Targeted Case Management Services (TCMS) (Mode 15, SFCs 01-09) from \$1.60 to \$1.74; Mental Health Services (MHS) (Mode 15, SFCs 10-19/30-59) from \$2.06 to \$2.24; Medication Support (Mode 15, SFCs 60-69) from \$3.82 to \$4.15; and Crisis Intervention (Mode 15, SFCs 70-79) from \$3.00 to \$3.34 under the existing Provider Number (PN) 7566. There is no change to the MCA.
- Amendment No. 2 (MH120337) with Didi Hirsch Psychiatric Service** decreases County General Funds (CGF) by \$127,113; and transforms \$127,113 into MHSA services. There is no change to the MCA.

5. **Amendment No. 5 (MH120344) with ENKI Health and Research Systems, Inc.**, increases the following rates for PNs 7173, 7253, 7254, 7255, 7258, 7360, 7452, and 7472 as follows: MHS (Mode 15, SFCs 10-19/30-59) from \$2.38 to \$2.61; TCMS (Mode 15, SFCs 01-09) from \$1.45 to \$1.92; Medication Support (Mode 15, SFCs 60-69) from \$4.36 to \$4.82; Mental Health Promotion (Mode 45, SFCs 10-19) from \$67.16 to \$82.37; Community Client Services (CCS) (Mode 45, SFCs 20-29) from \$67.16 to \$82.37; and Case Management Support (Mode 60, SFCs 60-69) from \$62.35 to \$82.45. In addition, the amendment increases the following rate for PNs 7258 and 7360: Day Treatment Intensive: Full Day (Mode 10, SFCs 85-89) from \$148 to \$195.72. Lastly, the amendment adds the following service to the current PN 7452: Outreach Services – Day Rehabilitation: Full Day (Mode 10, SFCs 95-99) at a rate of \$131.24. There is no change to the MCA.
6. **Amendment No. 1 (MH120354) with Gay and Lesbian Adolescent Social Services, Inc.**, shifts Early and Periodic Screening, Diagnosis, and Treatment (EPSDT) State General Funds (SGF) by \$7,105 to Healthy Families (HF) Federal Financial Participation (FFP), and EPSDT CGF by \$3,826 to HF MHSA Full Service Partnership (FSP) – Transition Age Youth (TAY). There is no change to the MCA.
7. **Amendment No. 1 (MH120372) with Los Angeles Unified School District** adds \$125,000 in one-time MHSA-Field Capable Clinical Services (FCCS) funding. The revised MCA will be \$2,926,300.
8. **Amendment No. 6 (MH120388) with PROTOTYPES, Centers for Innovation in Health, Mental Health and Social Services** shifts MHSA Wellness Centers Non-EPSDT Medi-Cal by \$100,000 to MHSA Adult FSP Non-EPSDT Medi-Cal. There is no change to the MCA.
9. **Amendment No. 3 (MH120389) with Providence Community Services, LLC** provides Department of Children and Family Services (DCFS) Intensive In-Home – Enhanced Specialized Foster Care (ESFC) – Non-Medi-Cal funding for one-time expenses associated with Program Development for the implementation of Intensive Evidence Based Treatment Practices as part of the Katie A. Strategic Plan. The revised MCA will be \$5,158,400.
10. **Amendment No. 4 (MH120389) with Providence Community Services, LLC** increases MHSA FSP-TAY CSS by \$10,296, MHSA FSP-TAY MHS by \$11,667, MHSA TAY FSP Non-EPSDT Medi-Cal match funds in the amount of \$5,834, MHSA FSP TAY MHS ESPDT Medi-Cal by \$1,192, Non-EPSDT FFP by \$5,833,

EPSDT SGF by \$7,558, and EPSDT FFP by \$8,750. The revised MCA will be \$5,209,530.

11. **Amendment No. 3 (MH120391) with San Fernando Valley Community Mental Health Center, Inc., (SFVCMHC)** for Fiscal Years (FYs) 2008-09 and 2009-10 adds a new Statement of Work (SOW) and Service Exhibit (Supportive Services – Residential Programs) for a pilot project that will provide housing and integrated health, mental health and substance abuse services for 30 of the most vulnerable, chronically homeless individuals living in San Fernando Valley. This amendment increases CGF by \$35,000 for FY 2008-09 and \$174,000 for FY 2009-10. The revised MCA will be \$27,959,800 for FY 2008-09 and \$27,641,300 for FY 2009-10.
12. **Amendment No. 6 (MH120391) with SFVCMHC** increases vocational/employment services funded by the Cooperative Agreement with the State of California – Department of Rehabilitation (State DOR) and decreases MHSA FSP Adult CSS in the amount of \$29,467. These funds will then be used as the State DOR required for County match for leveraging Federal Funds. The revised MCA will be \$27,920,333.
13. **Amendment No. 3 (MH120409) with The Los Angeles Gay and Lesbian Community Services Center dba L.A. Gay and Lesbian Center** decreases State Human Immunodeficiency Virus (HIV)/Acquired Immune Deficiency Syndrome (AIDS) funding by \$24,866. The revised MCA will be \$197,934.
14. **Amendment No. 2 (MH150140) with Kedren Community Health Center, Inc., dba Kedren Acute Psychiatric Hospital Out-patient Pharmacy** is being executed under delegated authority by the Board letter adopted on July 29, 2008, Agenda Item No. 23, to implement the Acquisition of Kedren Community Health Center, Inc., dba Kedren Acute Psychiatric Hospital Out-patient Pharmacy by Prime Pharmacy Services, Inc.
15. **Agreement (MH190046) with Pacific Clinics** is a new Agreement for Drop-In Centers TAY Services for FYs 2009-10, 2010-11, and 2011-12 with a TCA of \$250,000 for each year.
