

SUBJECT: AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 47 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of August, as follows:

1. **Amendment No. 11 (DMH-01656) with South Central Health and Rehabilitation Program (SCHARP)**, amends the conditions set forth in Amendment No. 8 under this Agreement, effective June 24, 2005, with respect to the disposition of certain funds provided to Contractor pursuant to Assembly Bill (AB) 2034 for Fiscal Year (FY) 2004-05.
2. **Amendment No. 8 (DMH-01662) with WRAP Family Services**, changes the method of reimbursement from Negotiated Rate to Cost Reimbursement.
3. **Amendment No. 2 (DMH-01739) with California State University, Long Beach Foundation**, revises the Preamble paragraph of the Agreement and includes additional language on Health Insurance Portability and Accountability Act (HIPAA) and Debarment.
4. **Amendment No. 11 (DMH-01829) with SHIELDS For Families, Inc.**, reduces Schiff-Cardenas Funds in the amount of \$40,000 unexpended from the Multi-Systematic Therapy (MST) program.
5. **Amendment No. 6 (DMH-01841) with Telecare Corporation**, adds \$11,250 of County General Funds (CGF) to the Maximum Contract Amount (MCA) to provide transportation services for the Mental Health Urgent Care Center to facilitate transfers from County Psychiatric Emergency Services (PES).

6. **Amendment No. 4 (DMH-01893) with Catholic Healthcare West dba California Hospital Medical Center**, changes the effective date of the new Provider No. 7590, identified as California Hospital Medical Center – California Behavioral Clinic Program, located at 1414 South Grand Avenue, Suite 300, Los Angeles, CA 90015, from June 15, 2005 to April 19, 2005.
7. **Amendment No. 4 (DMH-01934) California Institute for Mental Health (CIMH)**, adds Mental Health Services Act (MHSA) Community Program Planning funds in the amount of \$280,000 to the total contract amount to continue the MHSA planning process and create a Community Services Support Plan in accordance with provisions of the MHSA guidelines established by the State Department of Mental Health (SDMH).
8. **Amendment No. 1 (DMH-02322) with Institute for Multicultural Counseling and Education Services, Inc. (IMCES)**, shifts \$35,000 from CGF Local Mental Health Plan (MHP) Non Medi-Cal funds to Non Early and Periodic Screening, Diagnosis and Treatment (ESPDT) - Medi-Cal Program, and adds Non EPSDT-Federal Financial Participation (FFP) in the amount of \$35,000 to the MCA for the provision of additional mental health services to adult mentally ill clients residing in the County of Los Angeles.
9. **Amendment No. 1 (DMH-02327) with Kedren Community Health Center, Inc.**, adds CGF in the amount of \$1,953,860 to fund 11 additional acute psychiatric inpatient beds for adults to address the increased demand on the County's PES.
10. **Amendment No. 1 (DMH-02329) with Koreatown Youth and Community Center, Inc.**, decreases gross Healthy Families funds in the amount of \$15,667 from the MCA for FY 2005-06.

The following five (5) amendments to Legal Entity Agreements (11 to 15) decrease CGF (Local MHP Non Medi-Cal) from the MCA to be used as a County Match to the State of California – Department of Rehabilitation Cooperative Agreement, which allow for the provision of vocational services to Los Angeles County's mentally ill clients for FY 2005-06:

12. **Amendment No. 1 (DMH-02293) with Didi Hirsch Psychiatric Service**, decreases \$24,275 from the MCA.

FY 2005-06, No Payment for Services Provided Following
Expiration/Termination of Contract Language.

41. **Amendment No. 1 to Medi-Cal Professional Services Agreements with two (2) individual providers**, updates Child Support Compliance Program language and adds a Board-mandated clause regarding Debarment, Suspension, Ineligibility, and Voluntary Exclusion.
