SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 20 amendments to existing Legal Entity Agreements and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of February, as follows:

1. **Amendment No. 2 (DMH-01161) with D'Veal Corporation dba D'Veal Family and Youth Services**, creates Financial Exhibit Column F to reflect the Contractor's request to have EPSDT services provided to the Pasadena Unified School District (PUSD) reimbursed at actual cost. The Maximum Contract Amount for Fiscal Year (FY) 2002-2003 remains the same at \$4,555,652.
2. **Amendment No. 2 (DMH-01163) with Hillview Mental Health Center**, reduces AB 2034 funds in the amount of \$60,463 to reflect an adjustment due to the reduction in the AB 2034 allocation for FY 2002-2003 and adds County General Funds (CGF) in the amount of \$60,463 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount of \$7,518,187.
3. **Amendment No. 3 (DMH-01164) with Pacific Clinics**, reduces AB 2034 funds in the amount of \$61,583 to reflect an adjustment due to the reduction in the AB 2034 allocation for FY 2002-2003 and adds CGF in the amount of \$61,583 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount of \$47,503,970.
4. **Amendment No. 2 (DMH-01165) with Portals**, reduces AB 2034 funds in the amount of \$89,575 to reflect an adjustment due to the reduction in the AB 2034 allocation for FY 2002-2003 and adds CGF in the amount of \$89,575 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount of \$10,850,712.

5. **Amendment No. 3 (DMH-01165) with Portals**, adds Supportive Housing Initiative Act Funds (SHIA) in the amount of \$207,560 to augment the Housing Option Made Easy (HOME) Teams Project. The new Maximum Contract Amount for FY 2002-2003 is \$11,058,272.
6. **Amendment No. 2 (DMH-01166) with South Central Health and Rehabilitation Program (SCHARP)**, reduces AB 2034 funds in the amount of \$95,173 to reflect an adjustment due to the reduction in the AB 2034 allocation for FYs 2002-2003 and 2003-2004 and adds CGF in the amount of \$95,173 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount of \$4,750,455 for FY 2002-2003 and \$4,636,348 for FY 2003-2004.
7. **Amendment No. 3 (DMH-01199) with Didi Hirsch Psychiatric Service**, reduces AB 2034 funds in the amount of \$30,791 to reflect an adjustment due to the reduction in the AB 2034 allocation for FY 2002-2003 and adds CGF in the amount of \$30,791 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount.
8. **Amendment No. 2 (DMH-01221) with Heritage Clinic and Community Assistance For Seniors dba Geronet**, adds CGF in the amount of \$12,547 to provide mental health care services for FYs 2002-2003 and 2003-2004. The revised Maximum Contract Amount for FY 2002-2003 is \$390,943 and for FY 2003-2004 is \$381,445.
9. **Amendment No. 2 (DMH-01226) with Kedren Community Health Center, Inc.**, reduces AB 2034 funds in the amount of \$27,992 to reflect an adjustment due to the reduction in the AB 2034 allocation for FY 2002-2003 and adds CGF in the amount of \$27,992 equal to the reduction in AB 2034 funds; adds Realignment funds in the amount of \$55,000 for client support services that were redirected due to the termination of the Supplemental Rate Program; and amends the Negotiated Rate for Hospital Administrative Day, Mode 5, Service Function Code 19, to \$231.30 per day.
10. **Amendment No. 4 (DMH-01241) with Mental Health Association in Los Angeles County**, reduces AB 2034 funds in the amount of \$135,482 to reflect an adjustment due to the reduction in the AB 2034 allocation for FY 2002-2003 and adds CGF in the amount of \$135,482 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount.
11. **Amendment No. 5 (DMH-01241) with Mental Health Association in Los Angeles County**, adds SHIA funds in the amount of \$103,780 to augment the HOME Teams Project which shall be paid through the existing Service Exhibit

entitled, Client Supportive Services. The new Maximum Contract Amount for FY 2002-2003 is \$10,235,686.

12. **Amendment No. 6 (DMH-01241) with Mental Health Association in Los Angeles County**, adds \$203,017 in McKinney Projects for Assistance in Transition from Homelessness (PATH) Federal Block Grant (FBG) funds to augment mental health services to clients with co-occurring severe mental illness and substance abuse disorders, and who are homeless or at imminent risk of becoming homeless. The new Maximum Contract Amount for FY 2002-2003 is \$10,438,703.
13. **Amendment No. 2 (DMH-01255) with San Fernando Valley Community Mental Health Center, Inc.**, reduces AB 2034 funds in the amount of \$43,668 to reflect an adjustment due to the reduction in the AB 2034 allocation for FY 2002-2003 and adds CGF in the amount of \$43,668 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount.
14. **Amendment No. 2 (DMH-01271) with Tri-City Mental Health Center**, reduces AB 2034 funds in the amount of \$10,637 to reflect an adjustment due to the reduction in the AB 2034 allocation for FY 2002-2003 and adds CGF in the amount of \$10,637 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount.
15. **Amendment No. 1 to Medi-Cal Professional Services Agreement with one (1) Individual Provider**, reduces the amount of automobile insurance coverage requirement from \$300,000 to the amount mandated by the State of California (\$15,000 Bodily Injury Liability, \$30,000 Property Damage Liability, \$5,000 Personal Injury Protection) and updates the indemnification language as requested by the Chief Administrative Office Risk Management Operations.
16. **Amendment No. 1 to Medi-Cal Professional Services Agreements with two (2) Individual Providers**, adds HIPAA language and language from the Office of the Inspector General; revises the Child Support Compliance language; and adds Jury Service language for FY 2002-2003.
17. **Amendment No. 2 to Medi-Cal Professional Services Agreements with three (3) Individual Providers**, adds HIPAA language and language from the Office of the Inspector General; revises the Child Support Compliance language; and adds Jury Service language for FY 2002-2003.
