SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 75 amendments to existing Legal Entity Agreements and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of January, as follows:

1. **Amendment No. 1 (73490) with Mental Health Association in Los Angeles County**, increases the Maximum Contract Amount by \$142,000 in Assembly Bill 2034 funds for the collection and evaluation of outcomes data generated by agencies participating in the AB 2034 Program.
2. **Amendment No. 3 (DMH-00964) with The Regents of the University of California, Los Angeles (UCLA)**, includes Board-mandated clauses; revises Cash Flow Advance language; and includes Early and Periodic Screening, Diagnosis and Treatment – State General Funds (EPSDT – SGF) and Federal Financial Participation (FFP) funds in the Maximum Contract Amount.
3. **Amendment No. 2 (DMH-01012) with Staff Care, Inc.**, extends the contract term for the second additional six-month period commencing on January 1, 2003 through June 30, 2003.
4. **Amendment No. 1 (DMH-01033) with Dubnoff Center for Child Development and Educational Therapy, Inc.**, extends the repayment plan for an additional 24 months.
5. **Amendment No. 1 (DMH-01172) with AMADA Enterprises, Inc. dba View Heights Convalescent Hospital**, provides a State-mandated rate increase for IMD Long Term Care providers.

6. **Amendment No. 1 (DMH-01179) with Braswell Enterprises dba Olive Vista and Laurel Park**, provides a State-mandated rate increase for IMD Long Term Care providers.
7. **Amendment No. 1 (DMH-01192) with Community Care Center, Inc.**, provides a State-mandated rate increase for IMD Long Term Care providers.
8. **Amendment No. 1 (DMH-01193) with Community Counseling Service of Los Angeles, Inc.**, restricts the expenditure of one-time only Master Tobacco funds of \$43,434 to December 31, 2002.
9. **Amendment No. 1 (DMH-01206) with Exodus Recovery, Inc.**, reduces AB 2034 funds in the amount of \$33,591 to reflect an adjustment due to the reduction in the AB 2034 allocation for Fiscal Year (FY) 2002-2003 and adds County General Fund (CGF) in the amount of \$33,591 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount for FY 2002-2003.
10. **Amendment No. 2 (DMH-01214) with Golden State Health Centers, Inc. dba Foothill Health and Rehabilitation Center and Sylmar Health and Rehabilitation Center**, provides a State-mandated rate increase for IMD Long Term Care providers.
11. **Amendment No. 1 (DMH-01216) with Harbor View Rehabilitation Center, Inc. dba Harbor View Adolescent Center**, provides a State-mandated rate increase for IMD Long Term Care providers.
12. **Amendment No. 2 (DMH-01222) with Homes For Life Foundation**, adds the Athena Project. The Maximum Contract Amount for FY 2002-2003 is \$706,470.
13. **Amendment No. 2 (DMH-01228) with LAMP, Inc.**, reduces AB 2034 funds in the amount of \$55,984 to reflect an adjustment due to the reduction in the AB 2034 allocation for FY 2002-2003 and adds CGF in the amount of \$55,984 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount for FY 2002-2003.
14. **Amendment No. 1 (DMH-01229) with Landmark Medical Services, Inc.**, provides a State-mandated rate increase for IMD Long Term Care providers.
15. **Amendment No. 1 (DMH-01240) with Meadowbrook Rehabilitation Center, Inc. dba Meadowbrook Manor**, provides a State-mandated rate increase for IMD Long Term Care providers.

16. **Amendment No. 1 (DMH-01256) with San Gabriel Valley Convalescent Hospital dba Penn Mar Therapeutic Center**, provides a State-mandated rate increase for IMD Long Term Care providers.
17. **Amendment No. 2 (DMH-01266) with Telecare Corporation**, shifts funding for the Homeless Outreach Program, Provider Numbers 7262 and 7406, by reducing AB 2034 in the amount of \$92,374 and replacing that funding source with CGF in the amount of \$92,374.
18. **Amendment No. 3 (DMH-01266) with Telecare Corporation**, provides a State-mandated rate increase for IMD Long Term Care providers.
19. **Amendment No. 1 to Medi-Cal Professional Services Agreements with twelve (12) Individual Providers**, reduces the amount of automobile insurance coverage requirement from \$300,000 to the amount mandated by the State of California (\$15,000 Bodily Injury Liability, \$30,000 Property Damage Liability, \$5,000 Personal Injury Protection) and updates the indemnification language as requested by the Chief Administrative Office Risk Management Operations.
20. **Amendment No. 2 to Medi-Cal Professional Services Agreement with one (1) Individual Provider**, reduces the amount of automobile insurance coverage requirement from \$300,000 to the amount mandated by the State of California (\$15,000 Bodily Injury Liability, \$30,000 Property Damage Liability, \$5,000 Personal Injury Protection) and updates the indemnification language as requested by the Chief Administrative Office Risk Management Operations.
21. **Amendment No. 1 to Medi-Cal Professional Services Agreements with ten (10) Individual Providers**, adds HIPAA language and language from the Office of the Inspector General; revises the Child Support Compliance language; and adds Jury Service language for FY 2002-2003.
22. **Amendment No. 2 to Medi-Cal Professional Services Agreements with thirty-two (32) Individual Providers**, adds HIPAA language and language from the Office of the Inspector General; revises the Child Support Compliance language; and adds Jury Service language for FY 2002-2003.
23. **Amendment No. 1 to Medi-Cal Professional Services Agreement with one (1) Group Provider**, adds HIPAA language and language from the Office of the Inspector General; revises the Child Support Compliance language; and adds Jury Service language for FY 2002-2003.
