SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 175 amendments to existing Legal Entity Agreements, Specialized Agreements, and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of January 2004, as follows:

1. **Amendment No. 6 (71402) with Electronic Data Systems Corporation dba EDS Corporation**, extends the contract term on a month-to-month basis, for up to a maximum additional three months through March 31, 2004. The Maximum Contract Amount shall not exceed \$420,000 for the extension period, January 1, 2004 through March 31, 2004.
2. **Amendment No. 9 (DMH-00964) with The Regents of the University of California, Los Angeles (UCLA)**, revises the contract language and changes the Negotiated Rates for Addendum D (Training, Intervention, Education, and Support (TIES) for Adoption) for Mode 15, Services Function Codes (SFC) 01-09 from \$1.53 to \$1.83, SFCs 10-19/30-59 from \$1.97 to \$2.36, and SFCs 60-69 from \$3.73 to \$4.38. Also, increases Federal Financial Participation (FFP) Medi-Cal funds in the amount of \$7,559; decreases FFP funds in the amount of \$23,707 for a net total FFP decrease of \$16,148; and increases Early and Periodic Screening, Diagnosis, and Treatment - State General Funds (EPSDT - SGF) in the amount of \$23,986, in order to reflect the FFP and EPSDT - SGF funding sources for Addendum D in DMH's Fiscal Year (FY) 2003-2004 Adopted Budget.
