SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 42 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of January, as follows:

1. **Amendment No. 2 (DMH-01398) with Victor Treatment Center, Inc. dba Willow Creek Treatment Center**, amends Agreement to increase Department of Mental Health (DMH) Daily Rate from \$160.00 to \$165.00 for Seriously Emotionally Disturbed (SED)/hearing children in Redding, Stockton, San Bernardino/Riverside, and Santa Rose sites, and from \$215.00 to \$220.00 for SED deaf children in the Santa Rosa site.
2. **Amendment No. 1 (DMH-01416) with Bell Gardens Manor**, amends Agreement to include the revised paragraphs on "Contractor's Obligation as a 'Business Associate' Under the Health Insurance Portability and Accountability Act of 1996"; and includes "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion - Lower Tier Covered Transactions (45 C.F.R. Part 76)" language.
3. **Amendment No. 1 (DMH-02102) with City of Gardena**, extends the total amount of the monthly Cash Flow Advance (CFA) payment from October through December FY 2005-06 only, and shall not exceed \$7,627 per month.
4. **Amendment No. 2 (DMH-02109) with Los Angeles Orphans Home Society dba Hollygrove**, adds Mode 15, Service Function Codes (SFCs) 70-79 (Crisis Intervention) to Provider No. 7343 at a provisional rate of \$2.29.

5. **Amendment No. 1 (DMH-02265) Venice Family Clinic**, deletes Exhibit I in its entirety for Fiscal Year (FY) 2005-06, and replaces it with Exhibit I-A, which implements a technical adjustment that reflects the Board approved published Non Medi-Cal rates for mental health services rendered in FY 2005-06.
6. **Amendment No. 1 (DMH-02271) with Asian Rehabilitation Services, Inc.**, changes the reimbursement method of payment from Cost Reimbursement to Negotiated Rate for Vocational Services, Mode 10, SFCs 30-39.
7. **Amendment No. 4 (DMH-02282) with Child and Family Center**, adds \$800,000 in Local Mental Health Plan (MHP) Non Medi-Cal Funds for the Individuals with Disabilities Education Act (IDEA) (Assembly Bill (AB) 3632 - SEP) program to ensure that all AB 3632 clients in the catchment area are provided with mental health services for FY 2005-06.
8. **Amendment No. 4 (DMH-02283) with Child and Family Guidance Center**, adds \$800,000 in Local MHP Non Medi-Cal Funds for the IDEA (AB 3632 - SEP) program to ensure that all AB 3632 clients in the catchment area are provided with mental health services for FY 2005-06 and 2006-07.
9. **Amendment No. 3 (DMH-02300) with ENKI Health and Research Systems, Inc.**, adds Early and Periodic Screening, Diagnosis, and Treatment (EPSDT)-County General Funds (CGF) in the amount of \$292,160, EPSDT-Federal Financial Participation (FFP) Medi-Cal funds in the amount of \$1,600,000, and EPSDT-State General Funds (SGF) in the amount of \$1,307,840, for a combined total increase of \$3,200,000 to the Maximum Contract Amount (MCA). Whereas, for FY 2005-06, County and Contractor intend to amend Agreement to decrease Substance Abuse and Mental Health Services Administration (SAMHSA) funds in the amount of \$37,600 from the MCA. The MCA shall be increased by a net total of \$3,162,400 for FY 2005-06.
10. **Amendment No. 3 (DMH-02321) with Homes for Life Foundation**, total amount of the monthly CFA payment shall not exceed \$144,567 per month.
11. **Amendment No. 3 (DMH-02308) with Florence Crittenton Services of Orange County dba Crittenton Services for Children and Families**, adds a new service site located at 3605 Long Beach Boulevard, Suite 110, Long Beach, CA 90807.
12. **Amendment No. 7 (DMH-02343) Pacific Clinics**, adds CGF Local MHP Non Medi-Cal in the amount of \$800,000, to the MCA.

13. **Amendment No. 8 (DMH-02343) with Pacific Clinics**, adds EPSDT-CGF in the amount of \$54,780, EPSDT-FFP Medi-Cal funds in the amount of \$300,000, and EPSDT-SGF funds in the amount of \$245,220, for a combined total increase of \$600,000, to the MCA. Whereas, for FY 2005-06, County and Contractor intend to amend Agreement to add EPSDT-CGF in the amount of \$27,390, EPSDT-FFP Medi-Cal funds in the amount of \$150,000, and EPSDT-SGF in the amount of \$122,610, for a combined total increase of \$300,000 to the MCA. Also, adds SAMHSA funds in the amount of \$37,600 to the MCA. The funds are being transferred from ENKI to be used to hire a parent advocate at an existing System of Care (SOC) program within Service Area 3, and the MCA shall be increased by a total of \$937,600 for 2005-06. The revised MCA shall be \$49,532,687.
14. **Amendment No. 3 (DMH-02355) with San Gabriel Children's Center, Inc.**, changes the provider site location identified as San Gabriel Children's Center, Inc., located at 1161 East Covina Boulevard, Covina, CA 91724 to 4734 North Grand Avenue, Covina, CA 91724, under the existing Provider Number 7274.
15. **Amendment No. 2 (DMH-02358) with South Bay Children's Health Center Association**, Outpatient Program Provider Number 7220A, and the Day Rehabilitation Program Provider Number 7220D, have re-located from 17800 Van Ness Avenue, Torrance, CA 90504, to 410 South Camino Real, Redondo Beach, CA 90277.
16. **Amendment No. 1 (DMH-02370) with Transitional Living Centers for Los Angeles County, Inc.**, amends the Provisional Negotiated Rates for Non Medi-Cal billable services as reflected in Schedule A: Mode 10, SFCs 30-39 from \$44.67 to \$51.37 for Provider Number 7162, and Mode 05, SFCs 80-84 from \$39.31 to \$45.21 for Provider Number 7163 for FYs 2005-06 and 2006-07.
17. **Amendment No. 2 (DMH-02379) WRAP Family Services**, shifts \$75,000 from CGF Non-EPSDT Medi-Cal County Match funds to CGF Local MHP Non Medi-Cal, and reduce Non-EPSDT Medi-Cal FFP in the amount of \$75,000, for a total decrease of \$75,000 from the MCA.
18. **Amendment No. 1 to Medi-Cal Professional Services Agreements with five (5) individual providers**, add the Board-mandated clauses: Notice to Employees Regarding the Safely Surrendered Baby Law and Contractor's Acknowledgement of County's Commitment to the Safely Surrendered Baby Law.
19. **Amendment No. 1 to Medi-Cal Professional Services Agreements with five (5) individual providers**, add additional HIPAA language and add a Guide to Procedure Codes and include a "crosswalk" of technical terms/definitions.

20. **Amendment No. 1 to Medi-Cal Professional Services Agreements with five (5) individual providers**, delete Exhibits B (Electronic Claims Submission), Exhibit B-1 (Electronic Claims Submission Signature Information Form), Exhibit B-2 (Communications Contractor and Subcontractor/Biller Form), Exhibit B-3 (Certification on SD/MC Claim) and replace them with a Trading Partner Agreement, Electronic Data Interchange/Direct Data Entry Selection (EDI/DDE).
21. **Amendment No. 1 to Medi-Cal Professional Services Agreements with five (5) individual providers**, change the Contractor's Exclusion from Participation in a Federally Funded Program language, add Attestation form, and include the Board-mandated Preamble.
22. **Amendment No. 1 to Medi-Cal Professional Services Agreements with five (5) individual providers**, update Child Support Compliance Program language and add a Board-mandated clause regarding Debarment, Suspension, Ineligibility, and Voluntary Exclusion.
