

SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 134 amendments to existing Legal Entity Agreements and Specialized Agreements, processed in the month of July, as follows:

1. **Amendment No. 3 (DMH-01629) with Asian Rehabilitation Services, Inc.**, allows for the extension of the Cash Flow Advance (CFA) in the amount of \$15,981 for the month of March 2005.
2. **Amendment No. 3 (DMH-01645) with Heritage Clinic & The Community Assistance Program for Seniors dba Gero-Net**, adds Mental Health Services Act (MHSA) funds in the amount of \$3,590 for the provision of outreach services for Fiscal Year (FY) 2004-05.
3. **Amendment No. 7 (DMH-01646) with Hillview Mental Health Center, Inc.**, adds \$19,458 in County General Funds (CGF) to provide Interim Funding for the Assertive Community Treatment (ACT) Program to maintain indigent ACT clients in the community placements for FY 2004-05.
4. **Amendment No. 8 (DMH-01646) with Hillview Mental Health Center, Inc.**, shifts \$60,000 from Assembly Bill (AB) 2034 Treatment to AB 2034 Client Support Services for FY 2004-05.
5. **Amendment No. 9 (DMH-01646) with Hillview Mental Health Center, Inc.**, shifts \$300,000 from Non Early and Periodic Screening, Diagnosis and Treatment Program (EPSDT)-Federal Financial Participation (FFP) CGF Match to Other CGF, \$300,000 from AB 2034 Treatment to AB 2034 Medi-Cal Match, and \$300,000 from Non EPSDT-FFP to AB 2034 FFP for FY 2004-05.

6. **Amendment No. 6 (DMH-01653) with PROTOTYPES**, adds Department of Public Social Services (DPSS) California Work Opportunity and Responsibilities to Kids (CalWORKs) Act funds in the amount of \$135,000 for Mental Health Services (MHS), and \$15,000 for Community Outreach Services (COS), and adds DPSS General Relief Opportunities for Work (GROW) funds in the amount of \$22,597 for MHS, for a combined total increase of \$172,597 to the Maximum Contract Amount (MCA).
7. **Amendment No. 10 (DMH-01656) South Central Health and Rehabilitation Program (SCHARP)**, provides clarification on the provisions set forth in the termination of the Subcontract Agreement with Wilshire Children's Center under this Agreement.
8. **Amendment No. 6 (DMH-01662) with WRAP Family Services**, decreases Non EPSDT-FFP funds in the amount of \$141,329 and shifts funds in the amount of \$141,329 from Non EPSDT-FFP CGF Match to Other CGF.
9. **Amendment No. 1 (DMH-01727) with Griffith Centers for Children, Inc.**, changes the Out-of-State Child Placement Agreement Contractor name from Emily Griffith Center, Inc., to Griffith Centers for Children, Inc.
10. **Amendment No. 7 (DMH-01757) with Associated League of Mexican-Americans, Inc. dba ALMA Family Services**, decreases DPSS GROW Act funds in the amount of \$25,000 from the MCA.

16. **Amendment No. 5 (DMH-01782) with Five Acres – The Boys' and Girls' Aid Society of Los Angeles County**, amends the provisional Cost Reimbursement Rates for the following Short-Doyle/Medi-Cal Services, as reflected in Schedule A: Mode 10, SFCs 95-99 (Day Rehabilitative: Full Day) from \$104.75 to \$115.12; Mode 15, SFCs 01-09 (Targeted Case Management Services) from \$1.45 to \$1.64; Mode 15, SFCs 10-30/30-59 (Mental Health Services) from \$1.69 to \$1.91; Mode 15, SFCs 58 (Therapeutic Behavioral Services) from \$1.69 to \$1.91; Mode 15, SFCs 60-69 (Medication Support Services) from \$1.96 to \$2.22; and Mode 15, SFCs 70-79 (Crisis Intervention Services) from \$2.25 to \$2.55.
