SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 164 amendments to existing Legal Entity Agreements, Specialized Agreements, Pharmacy Agreements, and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of March, as follows:

1. **Amendment No. 1 (DMH-01020) with California State University, Long Beach Foundation**, revises the compensation amount from \$577,500 and \$635,250 to \$288,335 and \$300,000, respectively, for Fiscal Years (FY) 2002-2003 and 2003-2004.
2. **Amendment No. 3 (DMH-01163) with Hillview Mental Health Center**, changes the Negotiated Rate for Day Rehabilitative Services Full Day (F/D) Mode 10, Service Function Codes (SFC) 95-99, from \$100.30 to \$100.21 for FY 2002-2003. The Maximum Contract Amount remains the same at \$7,518,187.
3. **Amendment No. 5 (DMH-01164) with Pacific Clinics**, changes the Negotiated Rates for Short-Doyle/Medi-Cal Services for FYs 2002-2003 and 2003-2004. The Maximum Contract Amount remains the same at \$47,693,970 for FY 2002-2003 and \$43,564,909 for FY 2003-2004.
4. **Amendment No. 4 (DMH-01165) with Portals**, adds Supplemental Rate Program (SRP) funds in the amount of \$113,333 and FFP funds in the amount of \$75,000 to the Maximum Contract Amount for FY 2002-2003. The revised Maximum Contract Amount is \$11,246,605 for FY 2002-2003.
5. **Amendment No. 5 (DMH-01165) with Portals**, adds Children's System of Care (CSOC) funds in the amount of \$16,320 to the Maximum Contract Amount and

changes the Negotiated Rates for Short-Doyle/Medi-Cal Services for FY 2002-2003. The revised Maximum Contract Amount is \$11,262,925 for FY 2002-2003.

6. **Amendment No. 3 (DMH-01166) with South Central Health and Rehabilitation Program (SCHARP)**, changes the Negotiated Rate for Case Management Brokerage Services, Mode 15, SFCs 01-09, from \$1.28 to \$1.27. The Maximum Contract Amount remains the same at \$4,750,455 for FY 2002-2003.
7. **Amendment No. 2 (DMH-01167) with Step Up On Second Street, Inc.**, reduces AB 2034 funds in the amount of \$8,398 to reflect an adjustment due to the reduction in the AB 2034 allocation for FY 2002-2003 and adds County General Funds (CGF) in the amount of \$8,398 equal to the reduction in AB 2034 funds with no change to the Maximum Contract Amount of \$1,843,617 for FY 2002-2003.
8. **Amendment No. 1 (DMH-01168) with VIP Community Mental Health Center**, temporarily changes the service site address from 1721 Griffin Avenue, Los Angeles, CA 90031 to 1739 Griffin Avenue, Los Angeles, CA 90031, due to renovation at the site.
9. **Amendment No. 1 (DMH-01175) with Aspen Health Services Corporation**, adds Supportive Treatment Options Program (STOP) funds in the amount of \$80,000 to fund outpatient services for indigent probationers for FYs 2002-2003 and 2003-2004. The Maximum Contract Amount is \$1,988,603 for FY 2002-2003 and \$1,722,251 for FY 2003-2004.
10. **Amendment No. 1 (DMH-01177) with Barbour and Floyd Associates**, adds Realignment funds in the amount of \$55,000 for client support activities that were redirected due to the termination of the SRP. The revised Maximum Contract Amount is \$1,681,585 for each FY 2002-2003, 2003-2004 and 2004-2005.
11. **Amendment No. 2 (DMH-01177) with Barbour and Floyd Associates**, changes the Negotiated Rate for Day Rehabilitative Services F/D, Mode 10, SFCs 95-99, from \$89.91 to \$89.84 for FYs 2002-2003, 2003-2004 and 2004-2005.
12. **Amendment No. 1 (DMH-01178) with Bienvenidos Children's Center, Inc.**, removes \$80,000 in STOP funds from the Maximum Contract Amount for FY

13. **Amendment No. 3 (DMH-01180) with Braswell Rehabilitation Institute for Development of Growth and Educational Services, Inc. dba B.R.I.D.G.E.S., Inc.**, changes the Negotiated Rate for Mode 05, SFCs 65-79. The Maximum Contract Amount remains the same at \$2,118,345 for FY 2002-2003.
 14. **Amendment No. 3 (DMH-01183) with Child and Family Center**, changes the Negotiated Rates for Mode 10, SFCs 85-89, Day Treatment Intensive and Mode 15, SFCs 10-19/30-59, Mental Health Services. The Maximum Contract Amount remains the same.

 17. **Amendment No. 3 (DMH-01193) with Community Counseling Service of Los Angeles, Inc.**, adds CSOC funds in the amount of \$90,000 to augment mental health services to children at risk of out-of-home placement and their families. The new Maximum Contract Amount is \$5,522,068 for FY 2002-2003.
 18. **Amendment No. 1 (DMH-01196) with Counseling and Research Associates, Inc. dba Masada Homes**, changes the program site for Provider Number 7432 to 108 West Victoria Street, Gardena, CA 90248.
 19. **Amendment No. 2 (DMH-01200) with Dubnoff Center for Child Development and Educational Therapy, Inc.**, changes the Negotiated Rates for Mode 10, SFCs 95-99, Day Rehabilitative Services F/D and Mode 15, SFCs 60-69, Medication Support. The Maximum Contract Amount remains the same.
