

SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 482 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Psychiatric Inpatient Hospital Services Agreements, and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of March, as follows:
