SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 136 amendments to existing Legal Entity Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), processed in the month of March, as follows:

1. **Amendment No. 18 (DMH-00964) with The Regents of the University of California, Los Angeles (UCLA) (TIES for Adoption)**, adds Early and Periodic Screening, Diagnosis and Treatment (EPSDT)-County General Funds (CGF) Growth Match funds in the amount of \$45,900, EPSDT-Federal Financial Participation (FFP) Medi-Cal funds in the amount of \$458,700, and EPSDT-State General Funds (SGF) in the amount of \$412,700, for a combined total increase of \$917,300 for Fiscal year (FY) 2004-05.
