**SUBJECT: AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 152 amendments to existing Legal Entity Agreements, Specialized Agreements, Pharmacy Agreements, Community Care Residential Facility Agreements, and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of May, as follows:

- 1. Amendment No. 4 (DMH-00964) with The Regents of the University of California, Los Angeles (UCLA),** adds Academic and Medical Teaching Services to Augustus F. Hawkins Mental Health Center and shifts \$110,000 from the Academic and Medical Teaching Services Program to fund the training at Augustus F. Hawkins Mental Health Center for Fiscal Years (FY) 2002-2003, 2003-2004, 2004-2005, and 2005-2006 and adds \$61,120 to Addendum A (Countywide Academic and Medical Teaching Services Program) for program augmentation at Augustus F. Hawkins Mental Health Center for FY 2002-2003 only. The revised Maximum Contract Amount for FY 2002-2003 is \$2,918,851.
- 2.
