**SUBJECT: MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 76 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of ten (10) new Agreements processed in the month of April 2011, as follows:

1. **Agreement (MH010081) with California State University Dominguez Hills** is being executed under the Affiliation Agreement for Student Professional Development Programs. The term of the agreement will be March 28, 2011, through June 30, 2015.
2. **Agreement (MH010084) with Dominican University of California** is being executed under the Affiliation Agreement for Student Professional Development Programs. The term of the agreement will be May 2, 2011, through June 30, 2015.
3. **Agreement (MH060062) with University of Southern California dba USC University Hospital** is being executed under the Mental Health Services Agreement. The term of the agreement will be March 1, 2011, through June 30, 2015.
4. **Agreement (MH100317) with LAMP, Inc.**, is being executed under the Technological Needs Project Funding Agreement. The term of the agreement will be April 28, 2011, through June 30, 2016.
5. **Agreement (MH190088) with Eli Lilly and Company** is being executed under the Los Angeles County Department of Mental Health and Eli Lilly and Company Business Agreement. The term of the agreement will be October 24, 2011, through April 23, 2012.

6. **Amendment No. 27 (MH010054) with The Regents of the University of California, Los Angeles** adds \$96,000 for the expansion of services to include research and program evaluation of the implementation of Mental Health Services Act (MHSA) related to services under Addendum A, Section A2.4 (Additional Academic and Medical Teaching Services, Program Evaluation and Research Focusing of Improving Services for Underserved Populations and Geographic Areas with a Substantial component in conjunction with the National Institute of Mental Health).
7. **Amendment No. 3 (MH040097) with Downtown Women's Center** changes the Administration Office of Downtown Women's Center from 325 South Los Angeles Street, Los Angeles, CA 90013, to 442 South San Pedro Street, Los Angeles, CA 90013, and also changes Downtown Women's Center address where services are being provided from 333 South Los Angeles Street, Los Angeles, CA 90013, to 434 South San Pedro Street, Los Angeles, CA 90013.
8. **Amendment No. 1 (MH050040) with California Institute for Mental Health** adds MHSA funds in the amount of \$482,583 to the Total Compensation Amount (TCA). For Fiscal Years (FYs) 2010-11 and 2011-12 combined, the TCA will be increased by \$482,583. The revised TCA will be \$2,904,583.
9. **Amendment No. 2 (MH060055) with St. Francis Medical Center** cancels contractor's eligibility to provide services under the Psychiatric Diversion Program (PDP).
10. **Amendment No. 8 (MH120561) with Child and Family Guidance Center** increases the Full Service Partnership (FSP) – Child Medi-Cal/Healthy Families (HF) Funded Program in the amount of \$215,938, with a revised Maximum Contract Amount (MCA) of \$25,600,284.
11. **Amendment No. 5 (MH120627) with Exodus Recovery, Inc.**, reduces MHSA Urgent Care Centers/Crisis Resolution Services Medi-Cal by \$723,298 and increases MHSA Urgent Care Centers/Crisis Resolution Services Non-Medi-Cal/Indigent by \$292,325, with a revised MCA of \$13,598,665.
12. **Amendment No. 6 (MH120627) with Exodus Recovery Inc.** adds a one-time fund of \$325,308 to MHSA Urgent Care Centers/Crisis Resolution Services Non-Medi-Cal/Indigent to provide additional indigent services for the Eastside and Westside Urgent Care Center under Provider Nos. 7646 and 7783, with a revised MCA of \$13,923,973.

13. **Amendment No. 12 (MH120666) with Special Service for Groups** decreases the MHSA FSP–Child Non-Medi-Cal/Indigent Funded Program in the amount of \$16,000; increases the MHSA FSF–Child Medi-Cal/HF Funded Program in the amount of \$286,482; decreases the MHSA FSP–Transition Age Youth (TAY) Non-Medi-Cal/Indigent Funded Program in the amount of \$80,892; increases the MHSA FSP–TAY Medi-Cal/HF Funded Program in the amount of \$326,000; decreases the MHSA FSP–Adult Non-Medi-Cal/Indigent Funded Program in the amount of \$105,000; increases the MHSA FSP–Adult Medi-Cal/HF Funded Program in the amount of \$197,971; decreases the MHSA FSP–Older Adult Non-Medi-Cal/Indigent Funded Program in the amount of \$4,849; increases the MHSA FSP–Older Adult Medi-Cal/HF Funded Program in the amount of \$12,000; increases the MHSA Field Capable Clinical Services (FCCS) Non-Medi-Cal/Indigent Funded Program in the amount of \$25,000, with a revised MCA of \$29,242,074.
14. **Amendment No. 4 (MH120679) with Telecare Corporation** decreases MHSA FSP Adult Non-Medi-Cal/Indigent Maximum Program Amount (MPA) by \$47,512 and increases MHSA FSP Adult Medi-Cal/HF MPA by \$117,575 for a net increase of \$70,063, with a revised MPA of \$9,773,057.
15. **Amendment No. 1 (MH140065) with Provo Canyon School, Inc.**, adds new service sites located at 4501 North University Avenue, Provo, Utah 84604, and 763 North 1650 West, Springville, Utah 84663, for mental health services to children and adolescents between the ages of 0-22 years of age. Contractor has a daily rate of \$95.00 for the provision of on-site mental health treatment services to emotionally disturbed children/adolescent clients placed into Out-of-State Child Placement programs.
16. **Amendment No. 2 (MH160122) with Western Ferndale, Inc. dba Western Ferndale Board and Care** creates a new permanent revenue source, administered by the State Department of Mental Health (SDMH), for the transformation and expanded delivery of mental health services provided by State and county agencies and requires the development of integrated plans for prevention, innovation, and system of care services.
