

SUBJECT: **AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 107 amendments to existing Legal Entity Agreements, Specialized Agreements, and Medi-Cal Professional Services Agreements (Individual and Group Providers) processed in the month of November, as follows:

84. **Amendment No. 2 to Medi-Cal Professional Services Agreements with two (2) individual providers**, adds additional HIPAA language; adds a Guide to Procedure Codes and includes a "crosswalk" of technical terms, definitions, and language; deletes Exhibits B, B-1, B-2, and B-3 and replaces them with a Trading Partner Agreement; and adds Electronic Data Interchange/Direct Data Entry (EDI/DDE) Selection, General Requirements Agreement, and Claim Submission Agreement.
85. **Amendment No. 3 to Medi-Cal Professional Services Agreements with two (2) individual providers**, changes the Contractor's Exclusion from Participation in a Federally Funded Program language, adds Attestation form, and includes the Board-mandated Preamble.

86. **Amendment No. 4 to Medi-Cal Professional Services Agreements with three (3) individual providers**, temporarily adds provisional payment language for the period effective October 16, 2003, until the IS, is fully functional and adds contract language in regards to "No Payment for Services Provider Following Expiration/Termination of Contract."
87. **Amendment No. 4 to Medi-Cal Professional Services Agreements with two (2) individual providers**, changes the Contractor's Exclusion from Participation in a Federally Funded Program language, adds Attestation form, and includes the Board-mandated Preamble.
88. **Amendment No. 6 to Medi-Cal Professional Services Agreements with 17 individual providers**, updates Child Support Compliance Program language and adds a Board-mandated clause regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion.
89. **Amendment No. 6 to Medi-Cal Professional Services Amendments with 12 group providers**, changes Board-mandated language: Contractor Responsibility and Debarment; Child Support Compliance Program; and adds "Certification Regarding Debarment, Suspension, Ineligibility and Voluntary Exclusion – Lower Tier Covered Transactions (45 C.F.R. Part 76)".
