SUBJECT: AMENDMENTS TO MENTAL HEALTH SERVICES AGREEMENTS

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 33 Amendments to existing Legal Entity (LE) Agreements, Specialized Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), and Clinical Assessment programs processed in the month of October 2008, as follows:

- 1. Amendment No. 9 (DMH-01750) with ValueOptions, Inc.,** extends the Mental Health Services Act (MHSA) Master Agreements List for three (3) years beginning Fiscal Year (FY) 2008-09. There is no change to the Maximum Contract Amount (MCA).
- 2. Amendment No. 1 (MH040074) with Union Station Homeless Services** changes the name of the contract from Union Station Foundation to Union Station Homeless Services. There is no change to the MCA.
- 3. Amendment No. 22 (MH120144) with Pacific Clinics** changes the address and name of Pacific Clinics (PC) Transition Age Youth (TAY) Full Services Partnership (FSP) program from 9864 Baldwin Place, El Monte, CA 91731 to PC Hope Center, 13001 Ramona Blvd., Suite H & I, Irwindale, CA 91706, under new Provider Number (PN) to be determined (TBD). The services to be provided at the service site are: (Mode 15, Service Function Code (SFCs) 01-09) Targeted Case Management Services (TCMS); (Mode 15, SFCs 10-19/30-59) Mental Health Services (MHS); (Mode 15, SFCs 60-69) Medication Support; (Mode 15, SFCs 70-79) Crisis Intervention; (Mode 45, SFCs 10-19) Mental Health Promotion; (Mode 45, SFCs 20-29) Community Client Services (CCS), and (Mode 60, SFCs 64/70-79) Client Supportive Services (CSS). There is no change to the MCA.

4. **Amendment No. 13 (MH120173) with Providence Community Services, LLC**, adds Department of Children and Family Services (DCFS) Intensive In-Home Enhanced Specialized Foster Care funds in the amount of \$41,636; Early and Periodic Screening, Diagnosis, and Treatment (EPSDT)–Federal Financial Participation (FFP) funds in the amount of \$305,700; and EPSDT–State General Fund (SGF) in the amount of \$264,064 for Intensive In-Home MHS provided under the Comprehensive Children's Services Program and Multisystemic Therapy evidence based practice service models. Decreases non-EPSDT-County General Fund (CGF) in the amount of \$108,000, and non-EPSDT FFP Medi-Cal in the amount of \$108,000. For FY 2008-09, the MCA will be increased by \$395,400, with a revised MCA of \$4,772,600.
5. **Amendment No. 9 (MH120179) with Transitional Living Centers for L. A. County, Inc.**, increases MHSA Wellness Centers–Non Client Run funds in the amount of \$233,000, with a revised MCA of \$1,882,836.
6. **Amendment No. 6 (MH120242) with Olive Crest Treatment Centers, Inc.**, implements the court-ordered change to the services reflected in the County plan by adding \$103,656 in EPSDT–SGF; \$120,000 in EPSDT–FFP; and \$16,344 of Intrafund Transfer from DCFS, with a revised MCA of \$1,455,509.
7. **Amendment No. 8 (MH120260) with St. Joseph Center** increases the Provisional Cost Reimbursement Rate for the following Outreach Services: (Mode 45, SFCs 10-19) Mental Health Promotion, and (Mode 45, SFCs 20-29) CCS from \$45.81 to \$55.72. It increases the Provisional Cost Reimbursement Rate for Support Services: (Mode 60, SFCs 60-69) Case Management Support from \$48.32 to \$58.77. There is no change to the MCA.
8. **Amendment No. 7 (MH120267) with Telecare Corporation** decreases Local Mental Health Plan (MHP) non-Medi-Cal–CGF by \$120,000; increases non-EPSDT–CGF and non-EPSDT-FFP in the amount of \$120,000, with a revised MCA of \$10,091,400.
9. **Amendment No. 7 (MH120281) with Westside Center for Independent Living, Inc.**, adds MHSA Outreach and Engagement funds in the amount of \$26,000 to provide CSS, with a revised MCA of \$168,600.

10. **Amendment No. 6 (MH120283) with WISE & Healthy Aging** adds Provisional Cost Reimbursement Rate for the following Outreach Services: (Mode 45, SFCs 10-19) Mental Health Promotion at the rate of \$68.00; and adds (Mode 45, SFCs 20-29) CCS at the rate of \$67.00 under the PN 7724. There is no change to the MCA.
11. **Amendment No. 1 (MH130003) with Victor Treatment Centers, Inc., dba Willow Creek Treatment Center** increases the Department of Mental Health's (DMH) Daily Rate from \$175.00 to \$180.00 for hearing children in the Redding, Stockton, San Bernardino/Riverside, and Santa Rosa sites, and from \$232.00 to \$237.00 for deaf children in the Santa Rosa site. There is no change to the MCA.
12. **Amendment No. 2 (MH150163) with Phnom Pich Pharmacy, Inc.**, changes ownership from Assignor, Phnom Pich Pharmacy, Inc., (Heng Eam Hong) to Assignee, Phnom Pich Pharmacy, Inc. (Phicoll Hong). There is no change to the MCA.
13. **Amendment No. 1 (MH180021) with LocumTenens.com, LLC**, increases the daily rate from \$1,050 to \$1,600, and the weekday hourly rate to \$200 for the difficult-to-recruit location in the Antelope Valley; deletes Paragraph 5 (Non-Exclusivity Contractor's Exclusion from Participation in a Federally Funded Program) in its entirety and the following substituted therefore Paragraph 5 (Local Small Business Enterprise Preference Program), and also replaces the Safely Surrendered Baby Law Fact Sheet. There is no change to the MCA.
14. **Amendment No. 4 (MH190010) with California State University, Long Beach Foundation (CSULBF)** decreases CGF in the amount of \$200,000, and increases MHSA funds in the amount of \$1,118,000. This increase will add stipends under DMH's Student Professional Development Program to 43 additional students. The Total Compensation Amount (TCA) will be revised to \$1,118,000.

The following two (2) amendments to LE Agreements (15 and 16) revise the payment provision (Paragraph 3), which adjust the prescription drug reimbursement rates at a Maximum Allowable Ingredient Cost plus \$3.35 professional fee for each provision dispensed:

15. **Amendment No. 1 (MH150145) with La Votre Rx, Inc.**

- 16. Amendment No. 1 (MH150167) with Recovery Pharmaceuticals, Inc., dba Knollwood Pharmacy**

The following two (2) amendments to LE Agreements (17 and 18) decrease/increase MHSA TAY FSP funds:

- 17. Amendment No. 13 (MH120261) with Star View Adolescent Center, Inc.,** decreases MHSA TAY FSP funding by \$48,000, with a revised MCA of \$26,385,700.
- 18. Amendment No. 10 (MH120262) with Step Up on Second Street, Inc.,** increases MHSA TAY FSP funding by \$48,000 to reflect the transformation services associated with the FY 2008-09 curtailment, with a revised MCA of \$3,028,000.

The following two (2) amendments to LE Agreements (19 and 20) revise and/or add Paragraphs Performance Standards and Outcome Measure, and/or Local Small Business Enterprise Preference Program, Compensation Language:

- 19. Amendment No. 9 (MH120205) with Childrens Hospital Los Angeles** revises Paragraph 10, (PERFORMANCE STANDARDS AND OUTCOME MEASURE) and adds Paragraph 62, (LOCAL SMALL BUSINESS ENTERPRISE PREFERENCE PROGRAM) language. There is no change to the MCA.
- 20. Amendment No. 1 (MH140036) with The Learning Clinic** revises Paragraph 5.0 (COMPENSATION) and adds Paragraph 53 (LOCAL SMALL BUSINESS ENTERPRISE PREFERENCE PROGRAM) language. There is no change to the MCA.

The following three (3) amendments to LE Agreements (21 to 23) add/move service delivery sites:

- 21. Amendment No. 5 (MH120192) with Asian American Drug Abuse Inc.,** adds a new service delivery site at AADAP–Project FACT, located at 1316 Gaviota Ave., Long Beach, CA 90813, and adds new Medi-Cal/Short-Doyle (MC/SD) PN to be assigned (TBA). This facility will be providing substance abuse services through the Substance Abuse and Mental Health Services Administration (SAMHSA) grant. There is no change to the MCA.

22. **Amendment No. 11 (MH120205) with Childrens Hospital Los Angeles** moves service delivery site Childrens Hospital Los Angeles – Queens Care Health & Faith Partnership from 4618 Fountain Ave., Suite 102, Los Angeles, CA 90029 to 1300 North Vermont Ave., Suite 809, Los Angeles, CA 90027, under existing MC/SD PN 7586. The services to be provided at this site are (Mode 15, SFCs 01-09) TCMS and (Mode 15, SFCs 10-19/30-59) MHS. There is no change to the MCA.
23. **Amendment No. 9 (MH120262) with Step Up on Second Street, Inc.**, changes the service delivery site for the Assertive Community Treatment Program under existing PN 7526 from 2701 Ocean Park Blvd., Suite 150 and 150B, Santa Monica, CA 90405 to 3435 Ocean Park Blvd., Suite 207, Santa Monica, CA 90405. There is no change to the MCA.

The following 10 Amendments to LE Agreements (24 to 33) revise the percentage pertaining to matching SGF and CGF or other eligible matching funds for EPSDT as approved by the State, effective July 1, 2008.
