SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 179 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 15 new Agreements processed in the month of July 2013 as follows:

- 1. Agreement (MH9039) with Guidance Community Development Center** is being executed under the Medi-Cal Professional Services Agreement. The term of the Agreement is from July 2, 2013, through June 30, 2014.
- 2. Amendment No. 10 (MH010089) with The Regents of the University of California, Los Angeles (UCLA)** intends to eliminate funding for the Post-Doctoral Training and Consultation Program, related to Addendum A, Subsection A2.5, by reducing the funds to the amount by \$25,000. The Total Contract Amount (TCA) is \$1,764,547.
- 3. Amendment No. 20 (MH120886) with Special Services for Groups** increases ten additional beds under the Institutions for Mental Disease (IMD) Step-Down Program; increases Non Medi-Cal/Non Healthy Families (HF) funds in the amount of \$204,400; and increases Medi-Cal/HF funds in the amount of \$613,200. The revised Maximum Contract Amounts (MCAs) for Fiscal Years (FYs) 2013-14 and FY 2014-15 are \$36,538,053 and \$35,603,429, respectively.
- 4. Amendment No. 1 (MH120908) with Exceptional Children's Foundation** extends the term of the Agreement for one additional year effective July 1, 2013, through June 30, 2014. The revised MCA is \$1,009,854.

5. **Agreement (MH180041) with JPE Healthcare Staffing, Inc.**, is being executed under the Temporary Psychiatrist Services Agreement from July 23, 2013, through June 30, 2017.
6. **Amendment No. 6 (MH190063) with ValueOptions, Inc.**, increases compensation rate for the provision of administrative services per month per eligible beneficiary from \$46.75 to \$47.69, effective July 1, 2013. There is no change to the MCA.
7. **Agreement (MH190114) with Venice Family Clinic** is being executed under the Subcontract Agreement between Venice Family Clinic (Contractor) and Edmund Edelman Westside Mental Health Center, County of Los Angeles Department of Mental Health (DMH), Subcontractor. The term of the Agreement is from July 1, 2013, through June 30, 2014. The Subcontract Agreement fund is \$102,000.
8. **Amendment No. 4 (MH210013) with Harbor Community Clinic** decreases MHSA PEI funds for One-Time Funding in the amount of \$16,000 and increases MHSA PEI funds for Specialty Mental Health Services in the amount of \$50,250. The revised Estimated Maximum Amount (EMA) is \$83,618.
9. **Agreement (MH220014) with Karen Bollow** is being executed under the Project Management (PM) Services Agreement. The term of the Agreement is from July 22, 2013, through June 30, 2018.
