SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 67 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of seven (7) new Agreements processed in the month of September 2010, as follows:

1. **Amendment No. 5 (MH050026) with Inez K. Mann dba Mann and Associates** decreases MHSA Community Services and Supports (CSS) funding by \$45,500. The revised Maximum Contract Amount (MCA) will be \$45,500.
2. **Amendment No. 4 (MH050029) with A Community of Friends** decreases MHSA CSS funding by \$6,250.
3. **Amendment No. 2 (MH060057) with The Regents of the University of California on behalf of the Resnick Neuropsychiatric Hospital at UCLA** repeals Amendment No. 1 that added the Psychiatric Mobile Response Team (PMRT) Psychiatric Outreach Diversion Program (PDP) under the direction of Department of Mental Health Countywide Resources Management; it is necessary in order to cancel Contractor's eligibility to participate in the PMRT PDP.
4. **Amendment No. 9 (MH120347) with Exodus Recovery, Inc.,** makes a technical correction to Amendment No. 7 originally executed on August 13, 2009, to correct funding misallocations that were erroneously stated on the Financial Summary.
5. **Amendment No. 3 (MH120572) with Hillview Mental Health Center, Inc.,** increases Urgent Care Centers/Crisis Resolution Services Funded Program, Medi-Cal/Healthy Families (HF) by \$138,410, decreases Urgent Care

Centers/Crisis Resolution Services Funded Program, Non-Medi-Cal/Indigent by \$138,410. There is no change in the MCA.

6. **Amendment No. 1 (MH120573) with JWCH Institute, Inc.**, changes service delivery site address from 114 East 5th Street, Los Angeles, CA 90013 to 521 S. San Pedro Street, Los Angeles, CA 90013, under Provider Number (PN) 7727; shifts \$133,368 from MHSA Wellness/Client-Run Centers Non-Medi-Cal/Indigent to MHSA Institutions for Mental Disease (IMD) Step Down Non-Medi-Cal/Indigent and \$133,342 from MHSA Wellness/Client-Run Centers Medi-Cal/HF to MHSA IMD Step Down Medi-Cal/HF. There is no change to the MCA.
7. **Amendment No. 2 (MH120603) with Asian American Drug Abuse Program, Inc.**, increases Other Mental Health Services (MHS) for Clients Under the Age of 21 Years Medi-Cal/HF Funded Program by \$604. The revised MCA will be \$413,653.
8. **Amendment No. 3 (MH120615) with Childrens Hospital Los Angeles** adds MHSA Full Service Partnership (FSP) Transition Age Youth (TAY) Medi-Cal/HF Funded Program by \$136,500, and MHSA FSP TAY Non-Medi-Cal/Indigent Funded Program by \$126,450. The revised MCA for Fiscal Years (FYs) 2010-11 and 2011-12 will be \$12,023,215 and \$11,825,715, respectively.
9. **Amendment No. 3 (MH120622) with D'Veal Corporation dba D'Veal Family and Youth Services** adds Therapeutic Behavioral Services (TBS) (Mode 15, Service Function Code [SFC] 58) to PN 7341. There is no change to the MCA.
10. **Amendment No. 2 (MH120637) with Helpline Youth Counseling, Inc.**, increases Other MHS for Clients Under the Age of 21 Years Medi-Cal/HF Funded Program by \$191. The revised MCA will be \$192,185.
11. **Amendment No. 2 (MH120644) with Koreatown Youth and Community Center, Inc.**, decreases MHSA Field Capable Clinical Services (FCCS) Funded Program, Non-Medi-Cal/Indigent Maximum Program in the amount of \$11,760, and increases MHSA FCCS Funded Program, Medi-Cal/HF Maximum Program in the amount of \$118,654. The revised MCA will be \$504,440.
12. **Amendment No. 3 (MH120654) with Pacific Clinics** decreases MHSA Prevention and Early Intervention (PEI) Medi-Cal/HF Funded Program in the amount of \$930,593 and MHSA PEI Non-Medi-Cal/Indigent Funded Program in the amount of \$9,452; increases Other MHS for Clients Under the Age of 21 Years Medi-Cal/HF Funded Program in the amount of \$903,587; decreases

MHSA PEI Non-Medi-Cal/Indigent Funded Program by \$37,500, and increases MHSA PEI Medi-Cal/HF Funded Program by \$717,017. The revised MCAs for FYs 2010-11 and 2011-12 will be \$73,968,092 and \$72,066,375, respectively.

13. **Amendment No. 4 (MH120666) with Special Service for Groups** decreases the MCA in the total amount of \$262,950 to delete 20 slots in the MHSA TAY FSP program; decreases MHSA FSP TAY Medi-Cal/HF Funded Program in the amount of \$136,500, and MHSA FSP TAY Non-Medi-Cal/Indigent Funded Program in the amount of \$126,450.
14. **Amendment No. 2 (MH120684) with Tobinworld** adds TBS (Mode 15, SFC 58) at a provisional rate of \$2.60 to PN 7530. There is no change to the MCA.
15. **Amendment No. 3 (MH120688) with United American Indian Involvement, Inc.**, increases Other MHS for Clients Under the Age of 21 Years Medi-Cal/HF Funded Program in the amount of \$7,295, with revised MCAs for FYs 2010-11 and 2011-12 of \$1,249,132 and \$1,219,132, respectively.
16. **Amendment No. 1 (MH140060) with Griffith Centers for Children, Inc.**, changes the Administrative Office's address from 14142 Denver West Parkway, Suite 225, Lakewood, CO 80401 to 8461 Turnpike Drive, Suite 100, Westminster, CO 80031.
17. **Agreement (MH160165) with Truhlar-Jones Enterprises, Inc., dba Olivia Isabel Manor** was executed so contractor can provide basic residential services to clients referred by the County Department of Mental Health effective July 1, 2010 through June 30, 2013.
18. **Agreement (MH190081) with A Community of Friends** is a Service Agreement for Supportive Services through the MHSA Housing Trust Fund effective July 19, 2010 through June 30, 2013.
19. **Agreement (MH190086) with Atlantic Recovery Services, Inc.**, is for Enhanced Emergency Shelter Programs for TAY effective September 30, 2010 through June 30, 2012.
20. **Amendment No. 1 (MH190086) with Atlantic Recovery Services, Inc.**, extends the term of the agreement for a period of three (3) years, adds new language, and revises Exhibit A (Statement of Work) and Exhibit B (Fee Schedule).

21. **Amendment No. 2 (MH190086) with Atlantic Recovery Services, Inc.**, revises Exhibit A-2 (Statement of Work) and Exhibit B-2 (Fee Schedule).
22. **Agreement (MH190087) with Alcott Center for Mental Health Services** extends the repayment period of outstanding unearned cash flow advance. Contractor shall repay County at the rate of \$8,568 per month over an eight-month period starting September 7, 2010 through May 31, 2010.
23. **Agreement (MH200112) with Curtis Jenkins Programs, Inc.**, is being executed to be added to the MHSA Master Agreement list beginning September 21, 2010 through June 30, 2011.
