SUBJECT: **MENTAL HEALTH SERVICES AGREEMENTS/AMENDMENTS**

Pursuant to the authority delegated to the Director of Mental Health by your Board, this is notification of the execution of 60 Amendments to existing and/or new Legal Entity (LE) Agreements, Specialized Agreements, Mental Health Services Act (MHSA) Agreements, Medi-Cal Professional Services Agreements (Individual and Group Providers), Clinical Assessment programs and execution of 11 new Agreements processed in the month of May 2014 as follows:

1. **Agreement (MH050148) with Prevention Science Consulting, LLC**, was executed under the Consultant Services Agreement. The term of this Agreement is from April 8, 2014, through June 30, 2017.
2. **Amendment No. 3 (MH060056) with Success Healthcare 1, LLC, dba Silver Lake Medical Center** has merged into a wholly-owned series of entities that are ultimately owned and controlled by Daniel S. Newman, in his capacity as a court appointed Receiver. Contractor to delegate the duties and assign the rights under this Agreement, from Assignor, Success Healthcare 1, LLC, dba Silver Lake Medical Center, to Assignee, Success Healthcare 1, LLC, dba Silver Lake Medical Center, a wholly-owned subsidiary of Success Healthcare, LLC, a wholly-owned subsidiary of Founding Partners Designee, LLC, a wholly-owned subsidiary of Founding Partners Stable-Value Fund, L.P.
3. **Amendment No. 11A (MH9021) with Vericare of California Medical Group** modifies the current Additional Group Providers Attachment VIII-10A and replaces it with Attachment VIII-11A.
4. **Amendment No. 2 (MH121019) with Foothill Family Service** decreases Specialized Foster Care (SFC) - Wraparound Medi-Cal/Healthy Families (HF) funds in the amount of \$387,000 and matches funds in the amount of \$26,355, and increases SFC Enhanced Mental Health Services Medi-Cal/HF funds in the

amount of \$387,000 and matches funds in the amount of \$26,355. There is no change to the Maximum Contract Amount (MCA).
